Parties go head-to-head over new alcohol proposals

By Pete Hayman

Both the Labour and the Conservative parties have set out their respective plans for dealing with alcohol abuse and anti-social behaviour.

Home secretary Alan Johnson set out five mandatory conditions, which will apply to all alcohol retailers to ensure "consistent good practice", including the prohibition of all-you-can-drink promotions.

Other conditions will include the banning of 'dentist's chairs'. where drink is poured directly into the mouth of customers, as well as the provision of free tap water and making sure smaller measures of drinks are available.

Johnson said: "Any premises that breach the code or any secondary conditions that have been imposed will face a range of possible sanctions, including losing their licence.

The mandatory code will be introduced in two stages, with the first three conditions being implemented from 6 April. The remaining measures will come into effect from 1 October.

Meanwhile, shadow home secretary Chris Grayling has outlined plans to give local authorities and police forces stronger powers over licensing if the Conservatives win the next election. Grayling also proposes a tax hike on super-strength beers and alcopops.

In response, British Beer and Pub Association CEO Brigid Simmonds said: "Pubs are struggling and the country is in recession. This is not the time to be burying business in yet more unnecessary red tape.

"All the powers needed to deal with problem premises already exist. The trouble is poor enforcement of the current laws. Adding to that pile is unhelpful."

Design competition launched for Scotland's V&A

Architects sought for ambitious £47m museum project on Dundee's waterfront

An international architectural competition is being launched to deliver a new landmark building for The V&A at Dundee, a centre of 21st century design for Scotland.

The structure will occupy a site at the centre of Dundee's redeveloped waterfront area to the south of Craig Harbour on a site to be created projecting out into the River Tay.

Mike Galloway, Dundee City Council's (DCC) director of city development, said: "A two-

stage architectural competition is about to be launched and we expect to have interest in this project from prominent

architects and designers from around the world."

The site is being made available through the Dundee Central Waterfront Partnership, a joint venture between DCC and Scottish Enterprise, which is revitalising the prime area of land linking the city centre with the River Tay.

The £47m V&A at Dundee is being delivered by a partnership between the Victoria and Albert Museum, the University of Dundee, the University of Abertay Dundee, Dundee City Council and Scottish Enterprise.

Nairn to launch new restaurant

Scottish celebrity chef Nick Nairn will open a new restaurant at the recently refurbished Doubletree by Hilton Dunblane Hydro hotel in Dunblane, Scotland.

Called the Kailyard by Nick Nairn, the 220-cover property will be the chef's first new site since the the eponymous Nairn's in Glasgow closed in 2003.

Set to open on 28 January, Kailyard by Nick Nairn aims to showcase a range of Scottish cuisine.

Historic parks receive Lottery funding

Heritage Lottery Fund confirms grants for restoration schemes at three UK parks

The Heritage Lottery Fund (HLF) and Big Lottery Fund (BIG) have announced that three historic parks are set to receive a share of more than £9m through the Parks for People programme.

Lloyd and Aveling Park in Walthamstow, London, has been awarded nearly £3.5m to help restore historic features, rejuvenate the landscape and enhance wildlife habitats at the 12-hectare (30-acre) park. A gallery and community space and a café are also planned.

Walsall Arboretum in the West Midlands will receive a £4.57m grant to help fund restoration work on the park's Grade II-listed boathouse, the clock tower and a bandstand, as well as two lakes.

A Grade II*-listed Garden Pavilion and children's play areas will undergo work at Hillworth Park in Devizes, Wiltshire, after it secured £1.2m from the HLF and BIG, while a new volunteer ranger scheme will also be introduced.

HLF chief executive Carole Souter said: "People often look to their local public park as a place to get fit, spend more time with family and friends or just take time out for reflection.

"HLF and BIG continue to invest in parks because we know that people really benefit from all these sorts of activities and from having green open spaces to enjoy."

Construction underway on Glasgow 2014 sites

Construction work has started on the new National Indoor Sports Arena (NISA) and Sir Chris Hoy Velodrome venues in Glasgow, which will be used to stage events at the 2014 Commonwealth Games.

Located on a 10.5-hectare (25.9-acre) site to the east of Glasgow, the new venues are being delivered by Hertfordshire-based construction firm Sir Robert McAlpine and will provide the main sports facility for the 2014 Games.

The NISA, which will host badminton events during the Games, will feature seating for 5,000 spectators, a 200m athletics track with hydraulic bends and field event facilities and three sports halls to be used as warm-up spaces and as

training and events spaces in their own right.

Facilities at the Sir Chris Hoy Velodrome will include a permanent seating capacity of 2,000 and standing capacity of 500 – increased to 4,000 for track cycling events during the Games, a Ralph Schuermanndesigned 250m cycling track and a roller sport park within the main track.

Elite athlete facilities comprising a conditioning suite, physiotherapy areas, medical rooms and seminar spaces will also form part of the scheme, along with a new headquarters for sportscotland and the Culture and Sport Glasgow sports development team.

Archie Graham, Glasgow City Council's executive member for the Commonwealth Games, said: "The arena and velodrome will be seen around the world when the badminton and indoor cycling events of the Glasgow 2014 Commonwealth Games are held here."

The construction process is scheduled to be completed by early 2012, while the Velodrome track is set to be installed in spring 2012.

New Kids In Museums manifesto unveiled

Document outlines a range of actions for attractions to do more to indulge children

Families want less technology and more simple hands-on experiences in museums, according to the new 2010 Kids In Museums manifesto.

The manifesto, launched by charity Kids In Museums, has been compiled from families' comments and wishes collected during museum visits in 2009.

The document highlights 20 actions that the charity wants all UK museums to adopt when entertaining families and their children, including calls for museums to introduce flexible family tickets, rather than only offering the standard two adults and two children.

Other actions include to be more height aware and display objects and labels so that a child can see them, to provide

big open spaces for children to let off steam and to be more hands on with their displays.

The manifesto says: "Be interactive not only with computer screens and fancy gadgets. Dressing up and getting messy are as important as buttons to push."

Kids in Museums director Dea Birkett said: "Of the thousands of visitors' suggestions we received for the 2010 Manifesto, hardly any mentioned technology and gadgets.

"Museums need to listen and provide sensual experiences, not clean and clinical ones."

Fire-hit Afan Lido facing 'extensive demolition'

An independent structural assessment of the Afan Lido complex in Port Talbot, which was severely damaged in a fire in December, has recommended the majority of the facility should be demolished.

More than 100 firefighters were called to battle the blaze at the 45-year-old complex on 16 December, which started around 5pm in the swimming pool area before spreading to other parts of the building.

Neath Port Talbot County Borough Council chief execu-

tive Steve Phillips revealed that although the sports hall will not require demolition, the pool complex, reception, gym and ballroom areas will.

Phillips said: "The report advises that extensive demolition is necessary and officers will be recommending a way forward to the council once financial and technical appraisals for demolition have been completed.

"Air tests carried out on the night of the fire, and subsequently, show normal air quality readings, confirming that asbestos disturbed as a result of the fire is confined inside the building."

The council has also confirmed a nearby Bowls Hall is set to reopen in the near future.

The deal will allow DW Sports Fitness to use Wigan Council as its single point of contact when working across the country on all of its health and safety issues. The Primary Authority scheme, launched by the Local Better Regulation Office in April 2009, gives companies the right to form a statutory partnership with a single local authority, designed to provide robust and reliable advice for other councils to take into account when carrying out inspections or dealing with non-compliance.

REPs to restructure and clarify role

Framework to be updated to make it more understandable to sector employees

The Register of Exercise Professionals (REPs) has announced plans to restructure as part of efforts to make its operations "more realistic" and "easier to understand".

Established in 2002, the organisation is owned by SkillsActive, the Sector Skills Council for Active Leisure, Learning and Wellbeing.

Registrar Jean-Ann Marnoch said that the organisation's framework will be updated to make it more understandable to people working within the health and fitness industry.

Marnoch said: "The previous framework was a good starting point for both REPs and SkillsActive but desperately needs updating to reflect current working practices as well as offering much-needed simplicity to those both within and outside the industry.



will be much more realistic and easy to understand."

According to a statement, the new structure is a revised set of National Occupational Standards developed by industry experts to reflect the needs of the industry.

The awarding bodies are currently writing qualifications to meet these new standards and the training providers will

then write the courses to meet the qualifications.

"All of this means new courses reflecting the new structure will not be available until after April 2010", the statement says.

The current 44 categories of accreditations will be cut to 24. Changes include an additional category at Level 2 – Physical Activity for Children. The Level 3 advanced fitness instructor has also been dropped.

Revamped gym opens in Ealing

A new fitness suite has opened at Ealing Squash and Fitness Club in London, following the completion of a £450,000 scheme to expand the site's existing gym facility.

The fitness suite has doubled in size from 1,800sq ft (167.2sq m) to 3,600 sq ft (334.4sq m) after three squash courts were converted to create a new two-level facility.

Life Fitness has installed 65 stations of cv equipment in a bid to help members to boost squash performance, as well a further 50 pieces of strength equipment.

Selby District Council has announced the start of work on a £1.1m renovation of the North Yorkshire town's Abbey Leisure Centre, which is set to take six months to complete.

Wigan Leisure and Culture Trust, which was appointed to operate Abbey Leisure Centre in September 2009, will oversee the improvements on behalf of the council - including the construction of a new health suite featuring a sauna and a steamroom.

Abbey Leisure Centre's fitness suite is set to be expanded to 180sq m (1,938sq ft) as part of the work, which will incorporate a 70sq m (753sq ft) dance

studio and a 50sq m (538sq ft) spinning studio. The gym will house 68 pieces of equipment supplied by Technogym.

The refurbishment project also includes the creation of a new multi-purpose room, which will be used for functions, meetings and crèche activities, as well as a café.

PCC approves Life Centre contractor

Council appoints London-based Balfour Beatty to deliver £46.5m leisure complex

Plymouth City Council (PCC) has approved construction firm Balfour Beatty as the main contractor for the city's £46.5m Life Centre project.

The green light was awarded following a detailed evaluation of five bids and workers are now expected to move on to the Central Park site at the beginning of February.

PCC leader Vivien Pengelly said: "Awarding this contract will mark the last crucial milestone in laying the groundwork for the Life Centre and we are really excited to be at this stage in the project."

Facilities at the complex will include a family leisure pool with flumes, beach entry and a

bubble pool, a climbing zone with a 15m (49.2ft) wall and aerial assault course, an eight-lane bowls centre and a 12-court multi-use sports hall.

A 150-station fitness suite, a 10-lane, 50m swimming pool with moveable floors and submersible boom, a diving pool, a dryside training facility for elite divers, multi-purpose areas for dance and martial arts and a youth gym, also form part of the development, as well as a sauna, a steamroom and changing facilities.

Pools set to close in council savings drive

Swimming pools at Shelton and Tunstall in Stoke-on-Trent, Staffordshire, are facing closure as part of efforts to help the local authority reduce expenditure over the next three years. Stoke-on-Trent City Council is also proposing that classes currently run at the Gymnastic Centre are moved to Dimensions Leisure Centre in a bid to base leisure provision on "quality rather than quantity".

Revamped Stevenage fitness suite reopens

SIV, through its subsidiary company SIV Enterprises Limited, will also help LIFE develop a masterplan for a proposed Leisure Hub in Troutbeck Bridge, via the year-long contract. The proposed Leisure Hub will include an 80-station fitness suite, three separate aerobics studios, 25m, eight-lane swimming pool with a floating floor and spectator seating for regional galas plus an indoor climbing wall.

£21m leisure centre unveiled in Buckinghamshire

Bletchley Leisure Centre – a new £21m health and leisure complex near Milton Keynes, Buckinghamshire – has opened its doors to the public.

Bedford-based contractor SDC Builders started construction work on the Holder Mathias Architects-designed centre in April 2008 as part of a wider multi-million pound scheme to improve Bletchley led by Milton Keynes Council.

Bletchley Leisure Centre will replace the town's former centre and includes a 780sq m (8,396sq ft) fitness suite with 100 machines supplied by Matrix Fitness Systems.

An eight-lane, 25m swimming pool; a sauna and steamroom; a six-court sports hall; four squash courts and a seven-rink bowls facility also form part of the site, along with a gymnastics hall, a multi-purpose hall and a café.

Work has also been carried out to create a plaza between Elizabeth Square and the building's entrance.

Fitness4Less announces plans to expand portfolio

Budget health club operator Fitness4Less has appointed leisure property specialists Christie

+ Co to oversee a major acquisition and development programme across the UK.

Bristol-based Fitness4Less launched its first fitness facility in September 2007 and is currently preparing to open two more sites.

Fitness4Less has tasked Christie + Co to find suitable locations on medium-term leases to meet its growth targets.

According to a spokesperson, the company is hoping to open new health clubs in a number of major cities across the UK, including Birmingham, Brighton and Cardiff.

Former Blue Chip casinos sold

Two casinos formerly operated by the failed Blue Chip Casinos company have been sold by the group's administrators. The two sites, Castle Hill in Dudley and The Rubicon in Wolverhampton, were sold for an undisclosed sum. Lawyers Davenport Lyons acted on behalf of Administrators UHY Hacker Young on the deal. Blue Chip Casinos were part of US-based Isle of Capri Casinos. Jonathan Lass, corporate partner at Davenport Lyons, said: "The transaction was completed in two weeks in order to safeguard jobs and the goodwill of the operating businesses."

Profits warning from Luminar

▶ Nightclub operator Luminar expects profits for the year to 25 February 2010 to be below expectations due to a combination of the recent bad weather and economic conditions. particularly the increase in youth unemployment. The company said it was "very encouraged" by much better sales on Christmas Eve and New Year's Eve and by average sales per customer, which were up 1.5 per cent in December when compared with last year. Same outlet sales for the month, however, were 13.8 per cent down on last year.

NFL set for Wembley Stadium return

The National Football League (NFL) has confirmed that a regular-season fixture will be played at London's Wembley Stadium on 31 October for the fourth consecutive year. San Francisco 49ers, the five-time Super Bowl champions, and two-time champions Denver Broncos will contest the fixture, which could be one of two regular-season matches played in the UK during 2010.

Salford racecourse scheme scuppered

Government rejects Peel's proposals for major Salford Forest Park development

Communities secretary John Denham has rejected Peel Holdings' multi-million pound plans for a new racecourse and nature reserve near Salford, Greater Manchester.

A public inquiry into the project was launched in April 2009 after Peel Holdings appealed to the government to intervene in the planning process after Wigan Council and Salford City Council (SCC) failed to decide whether to back the Salford Forest Park plans.

The development proposals included a new international standard horse racing course, boasting a 6,000-seat grandstand, an eventing course and an equestrian centre at the centre of the 1,690-acre (684-hectare) site, as well as an 18-hole golf course.

An 80-bedroom hotel with a gym, a restaurant and a

swimming pool, a forest park visitor centre and an eco-village, as well as 11 miles (18km) of cycle trails and 20 miles (32km) of footpaths were also earmarked for the site.

SCC lead member for planning Derek Antrobus said: "While the council's planning panel always recognised that Peel's proposals offered some economic and social benefits to Salford, it also recognised that

the location of the scheme, lying in the green belt, posed some particular difficulties.

"The inspector and secretary of state clearly shared these concerns and have found that harm outweighs any benefits in this case and have accordingly dismissed the appeal."

SCC had raised opposition to the scheme due to the impact the development would have on green belt land.

HMV secures MAMA takeover

Music retailer HMV has acquired live music group MAMA in a deal worth around £46m.

In a statement, HMV said it had agreed a deal that will see the group pay 5.4p for each MAMA share and aims to build on a joint venture between the two groups unveiled last January.

HMV believes it will be able to increase growth of the live venues and the festivals business and will also be able to drive further cost and "revenue synergies" out of operating them alongside HMV's existing businesses.

Racing undeterred by downturn

Attendance levels at racecourses across the UK remained stable during 2009 despite the challenging economic climate, according to new figures published by the Racecourse Association (RCA).

The total number of people attending horse racing events during the 12-month period increased by 2,000 to 5,718,729 when compared with 5,716,656 for the previous year, although the average daily attendance decreased by 0.22 per cent to 4,008.

Stephen Atkin, chief executive of the RCA said: "The figures would have been even better but for December

suffering abandonments during the cold snap, which has continued to make January a very testing time for courses.



Conwy County Borough Council has given the go-ahead for the facility, which will boast a rugby training pitch, a 2,000-seat grandstand, team changing facilities, a weights room and floodlights. Parc Eirias will also provide a home for the new Rygbi Gogledd Cymru (North Wales Rugby) regional team.

Portsmouth FC fails in High Court application

▶ Portsmouth Football Club has failed in its attempts to get the High Court to dismiss a winding up petition brought against the club by HM Revenue and Customs. Despite rejecting the Premier League club's bid to 'strike out' the petition, Mr Justice Newey granted the club permission to lodge an appeal against the decision. PFC is hoping to avoid a final hearing of the winding up order on 10 February. The ruling comes a week after the club was told by the Premier League that its £7m share of television revenue was being diverted to football creditors.

Sport England appoints new COO

Law Society group finance director Rona Chester has been appointed to the newly-created role of chief operations officer (COO) at Sport England. Chester, who will take up her position on 1 March, will be responsible for finance, business planning and grants management, while also supporting Sport England's chair and chief executive in the organisation's bid to create a "world-leading community sport system" for England.

Gold and Sullivan seal West Ham deal

Former Birmingham City Football Club owners secure 50 per cent stake in club

West Ham United Football Club (WHUFC) has confirmed that former Birmingham City Football Club (BCFC) owners David Gold and David Sullivan have acquired a 50 per cent stake in the club.

The deal, which values the club at £105m, was concluded on 18 January and will result in the pair taking over operational and commercial control from former owner, asset management company CB Holding.

Sullivan and Gold, who left BCFC last September after the Midlands club was the subject of a successful takeover by businessman Carsten Yeung, will be joined at WHUFC by former colleague Karren Brady.

As well as looking to reduce the club's £100m debt through external investment, Sullivan has also outlined plans to move to London's Olympic Stadium.

Sullivan said: "Our long-term aim will be to put the club on a stronger financial footing.

"I believe with our new board we have the expertise and experience to do just that.

"We have got to look at all sorts of ways of bringing in revenue. We will be looking at everything, from saving money to bringing money in."

Everton FC confirms 'positive' stadium discussions

Everton Football Club (EFC) has confirmed that it has held "positive" discussions with Liverpool City Council (LCC) over potential sites for the future development of a new stadium.

The Premier League club is now looking at options within the city boundary after plans for a 50,000-seat venue at Kirkby as part of a joint scheme with Tesco were rejected by the government in November.

Improvements to the town centre, new leisure facilities, a new Tesco Extra store and a

housing development were also included as part of the Destination Kirkby scheme, which was rejected by communities secretary John Denham despite the approval of Knowsley Council.

In a joint statement, EFC and LCC said: "A positive meeting took place between Everton FC and Liverpool City Council about future stadium options within the city boundary, and more discussions have been scheduled for the near future."

Work starts on North Tyneside indoor tennis centre

Construction work has started on a new indoor tennis complex at Churchill Community College in Wallsend, North Tyneside, to create an all-weather facility for students, residents and tennis clubs.

The four-court centre, consisting of a steel-framed waterproof fabric structure, is set to be built over the school's existing tennis courts, which will also undergo improvements as part of the scheme and will link with other indoor sports areas.

The Lawn Tennis Association has invested nearly £550,000 as part of British Tennis' Places to Play strategy, while the Department for Children, Schools and Families has also contributed.

Newham Aquatics will act on the behalf of residents to secure access to the best swimming facilities, including the 2012 Aquatics Centre.

The Olympic Park Legacy Company, which will manage the Aquatics Centre after the 2012 Games, has backed the formation of the new partnership as part of efforts to increase participation.

Canoe centre's launch date confirmed

The Cardiff International White Water centre will open to the public in April. Cardiff Council leader Rodney Berman confirmed the opening date during a test run of the £13.3m centre's turbine pumps on 11 January. The centre, based adjacent to Cardiff International Pool at Cardiff International Sports Village, will provide the UK with its first Olympic-standard pumped water canoe slalom course, offering canoeing and white water rafting facilities.

Work starts on Antrim cricket facilities

Northern Irish sports minister Nelson McCausland has attended a turf cutting ceremony to mark the start of construction work on new cricket facilities at Muckamore Cricket and Lawn Tennis Club, County Antrim. The Northern Ireland Executive has contributed £124,000 towards the scheme through the Department for Culture, Arts and Leisure and Sport Northern Ireland, which will include six new turf cricket pitches and one new artificial cricket pitch. Two full-size covered training bays and new drainage at the second ground to allow for the creation of a football pitch also form part of the development at the venue.

Manchester Airkix centre opens

A £4.4m indoor skydiving centre has opened at the Trafford Quays Leisure Village in Manchester. Owned and operated by Airkix – which runs another centre in Milton Keynes – the new facility will boast a tunnel with a 14ft diameter and a 35ft-high flight chamber, making it the largest in the UK. The centre was partly funded by The Royal Bank of Scotland, which provided £2.5m.

Historic Surrey estate closes to public

▶ A historic estate formerly owned by press baron Lord Beaverbrook will not be open to visitors this year after its owner, The Beaverbrook Foundation. announced that it was no longer financially viable. Two consecutive wet summers and the economic downturn have been blamed for the decision to close Cherkley Court and Gardens near Leatherhead, Surrey, which is set in 400 acres (162 hectares) of park and woodlands.

Maritime museum planned for Derry

▶ A maritime museum is being planned for the former British Army barracks at Ebrington, Derry, Northern Ireland. According to the Derry Journal, the project is the brainchild of urban regeneration company Ilex, in partnership with Derry City Council. A spokesperson for the council said: "We are currently seeking applications for the supply of a feasibility study and economic appraisal into the establishment of a maritime museum development at Ebrington in Derry."

Paultons handed ride planning reprieve

Paultons Park near Southampton, Hampshire, has been told that it can keep its Cobra ride after being granted retrospective planning consent by the New Forest National Park Authority (NFNPA). In October 2009, park bosses were told that they would have to remove both the Cobra and the Edge roller coasters, which were opened without having secured the necessary permission. However, planning officials at NFNPA have now decided to allow the park to retain the Cobra ride, as well as a control building, catering kiosk and a photograph booth.

Makeover for Royal Fusiliers Museum

Historic London attraction set for major refurbishment after securing HLF grant

Plans for the refurbishment of a museum dedicated to the history of the Royal Regiment of Fusiliers at the Tower of London have been handed a £300,000 boost by the Heritage Lottery Fund (HLF).

Housed in the Grade I-listed Officers Mess building dating back to 1845, the Royal Fusiliers Museum opened to the public in 1962 and boasts a range of exhibits from the regiment's 400-year history.

The scheme will see the museum expanded to allow more items to be put on show, including a new medals gallery.

An education programme for local Tower Hamlets schools and community volunteering opportunities are also planned.

New live interactive displays will be created at the attraction by 2011 to coincide with the

Tower of London's year of celebration dedicated to the theme of Menagerie, including a Victorian soldier outlining the role of animals in warfare.

Sue Bowers, head of the HLF London, said: "The newly developed museum will add to the attractions that bring more than two million visitors to the Tower of London each year while providing the chance for

local people, from a range of backgrounds, to engage with their local army regiment."

Colin Bowes-Crick of the Royal Fusiliers Museum Trust added: "The finished product will significantly enhance the visitor experience – especially for local residents who will benefit not only from visiting the museum but also from our proposed outreach programme."

Museum unveils new restaurant

The Natural History Museum (NHM) in London has launched a new 270-seat restaurant.

Designed by a partnership involving architects RWCA and interior designers Path Design, the 6,500sq ft (604sq m) restaurant is the third of the museum's visitor catering zones to be revamped in the space of 12 months.

The museum had to obtain a listed building consent to create the eatery, as the plans included breaking through the original building fabric to an adjacent gallery to open up extra space, which was used to bring the kitchens front-ofhouse - an unusual feature for a museum restaurant.

The restaurant is part of a £3m refit and facilities revamp programme for the attraction, and completes a strategic remodelling of the eating and refreshment facilities.

The three-phase overhaul has been project-managed by Cultural Innovations, which has been responsible for co-ordinating the consultant team.

'Psychoaster' set for Alton Towers

Alton Towers in Staffordshire is set to launch a new £15m rollercoaster in March, which is being touted as a terror-thrill ride, or "psychoaster".

An Alton Towers spokersperson said the new Thirteen attraction will be "based on the discovery of an unearthed ancient burial site in an area of unexplored woodland known as the Dark Forest".

Only visitors aged between 16 and 55 years old will be allowed to ride the new rollercoaster, which has been built on the site of Alton Towers' former Corkscrew ride dismantled in late 2008.

The new Thirteen rollercoaster is scheduled to open to the public on 20 March.

Kent horse sculpture plans submitted

'Angel of the South' proposals submitted to Gravesham Borough Council planners

Cardiff set for new centre for the creative industries

A new centre for the creative industries, which will boast a BBC drama production complex, is set to be developed in Cardiff under plans due to be submitted next month.

Welsh deputy first minister leuan Wyn Jones has confirmed the Welsh Assembly Government is working in partnership with Cardiff Council and the BBC to build a new Digital Media Centre on a 27-acre (11-hectare) site at Roath Basin in Cardiff Bay.

The scheme, which will form the second stage of the wider Media Capital project, aims to provide a media hub for a range of independent production companies.

▶ Brunning & Price, The Restaurant Group's pub arm, has acquired the The Nevill Crest & Gun near Tunbridge Wells from Whitbread, The Grade II-listed pub is believed to date back more than 500 years and until recently was operated under the Brewers Fayre brand. The property includes a main bar with two seating areas, an 84-cover restaurant, a 90-cover beer garden, and a large car park. The site also includes a flat, bedsit, and attic rooms, plus manager's four-bedroom accommodation within a detached converted barn.

UCL to open 15 pubs over next two years

▶ Pub operator Urban & Country Leisure (UCL) will open fifteen new pubs over the next two years. The expansion is part of a £10m investment programme for the company, which currently operates 12 pubs in the UK. The roll out will be funded by a group of private investors which includes Birmingham-based Bridgehouse Capital. UCL markets its properties as affordable gastro pubs

Whitbread to expand 'green portfolio'

Hospitality giant to launch second environmentally-friendly budget hotel in London

Hotel and restaurant group Whitbread has revealed plans to open its second green Premier Inn hotel and its first low-carbon restaurant.

The launches are part of its Good Together sustainability programme, which aims to cut carbon emissions by a quarter (26 per cent) by 2020.

Whitbread will build a environmentally-friendly, 60-bedroom Premier Inn hotel in Burgess Hill, West Sussex. Scheduled to open in Autumn 2010, the hotel is designed to deliver 70 per cent carbon and 60 per cent water savings.

It is the second 'green' Premier Inn in the UK – the first opened in Tamworth in 2008 - and features a Beefeater

restaurant adjacent to the property, which will share the hotel's carbon-saving solutions, including ground-source heat pumps, rainwater harvesting and grey water recycling.

Both the Premier Inn hotel and Beefeater restaurant at Burgess Hill will be built using

timber frame construction methods from sustainably sourced wood. Timber frame has the lowest carbon content of any commercially-available building material and its flexible design allows for high levels of insulation to achieve maximum energy efficiency.

Prezzo acquires Stortford hotel

Prezzo, the casual Italian-style restaurant operator, has acquired the 26-bedroom George Hotel in Bishop's Stortford. Hertfordshire from Punch.

Prezzo, which owns 140 restaurants across the UK, will occupy the ground floor and basement and is now exploring options for the rest of the property. which could include selling off the upper parts.

Brandon Elmon, director of agency and acquisitions at Davis Coffer Lyons, who handled the deal, said: "Acquiring this type of property is a new source of opportunity for Prezzo and is something that we will be actively seeking countrywide in 2010."

The value of hotel properties in the UK fell by a third during 2009

The property values of hotels, restaurants and pubs all suffered heavy falls during 2009, while the emergence of new budget health club chains gave the fitness industry a much-needed lift.

According to the Business Outlook report, published by leisure property specialist Christie + Co, the average hotel value declined by 34 per cent in 2009, while the value of restaurants fell by 30 per cent and pubs by 29 per cent.

Christie + Co head of hotels Jeremy Hill said most completed property deals in the hotel sector involved companies that were in administration or had to offload property to bump up cash flow.

"Distressed cases made up the majority of transactional activity that took place during the year", he said.

£20m revamp for Glasgow hotel

Grand Central Hotel poised for September reopening

Glasgow's Grand Central Hotel, which was acquired by operator Principal Hayley in spring 2009, is set to reopen in September, following the completion of a £20m revamp.

The 350,000sq ft (32,516sq m) property will boast 240 bedrooms, a Champagne bar overlooking the city's Central Station, a deli, a restaurant and a bar, as well as 21 meeting rooms and the revamped Grand Ballroom of Glasgow.

A number of the 127-year-old hotel's original features will be

reinstated as part of the work – such as the ballroom's coffered ceiling, which will be raised by 3m (9.8ft) to uncover a second set of windows hidden for 30 years.

Architect Charles Leon is behind the designs for the new-look hotel, which aims to establish itself as one of the city's leading conference venues.

Principal Hayley chief executive Tony Troy said: "The acquisition of the Grand Central Hotel is in keeping with our strategy of offering dedicated conference hotels in key city centre locations around the UK."

December boost for restaurants

UK pub and restaurant companies have been boosted by a 2.9 per cent increase in like-for-like sales during December 2009, according to figures published by the latest monthly Coffer Peach Business Tracker.

Compared with the same period in 2008, the tracker – run in partnership between the Coffer Group, KPMG and UBS – showed a 4.7 per cent increase in total sales, with

consumers continuing to spend despite the recession.

The increase in like-for-like sales for December was the ninth consecutive month of growth for the 15 pub and restaurant operators that contribute towards the data including Pizza Hut, Punch Taverns and pub group Mitchells and Butler.

Month-on-month sales were up nearly a quarter compared with November.

Not all doom and gloom for hospitality sector

Growth in domestic market and weak pound could continue to benefit operators in 2010

here is little doubt that 2009 was a tough year for many, and the hospitality industry was affected as much as other sectors. Nevertheless, there were many examples of success despite the grim forecasts at the beginning of 2009.

The UK hotel sector has been under severe pressure, with room yield in the first three quarters of 2009 in both London and the province experiencing declines. At the same time, there was strong growth in the domestic market during a year when people decided to remain in the UK for their holidays, preferring to take shorter breaks. Given the continuing cost pressures on airlines, and the consequent increase in fares, this trend is likely to continue through 2010.

At the same time, the global economic challenges remain, with some predicting that we are far from being out of the recession. In this scenario, the weak pound will continue to attract visitors to the UK, with many now seeing it as a more affordable destination. This is certainly the view of many of the leading international brands such as Accor, Starwood and Corinthia, each of whom is making sizeable investments in the UK over the next two years.

And we must not forget the 2012 Olympics. Despite the downturn, the clock has not stopped ticking. Whether we like it or not, the world will descend on London and other parts of the UK for a brief but hectic period in 2012. It is not a question of 'will we be ready' but a matter of 'we have to be ready'.

A key element to our successful hosting of the Games will be our ability to provide excellent hospitality and outstanding customer service. We now have very little time left to get ourselves into shape, but what better spur to activity than this, arguably the greatest show on earth.

So, despite the general air of despondency there is much about which to be positive. Moreover, there is a great future awaiting the industry as we move slowly out of recession. Will it be hard work? Of course it will, but the rewards will be worth the effort for those who maintain their focus on skills development and improving their customer service standards, both aspects which lie at the heart of what the Institute of Hospitality is about.

To paraphrase a well-known military axiom: 'When the going gets tough, the tough (and well trained) get going'!

New strategy to improve Welsh waters

▶ Environment Agency Wales and the Welsh Assembly Government have launched a new set of measures, which have been drawn up to further improve the quality of Welsh waters by 2015. The River Basin Management Plans form part of efforts to improve and protect the water environment across England and Wales in order to meet new European Union targets and will bring together water companies, farming groups, industry and local authorities. Welsh rivers, lakes, estuaries, coastline and groundwaters are set to benefit as a result of the new measures.

New plans for Scottish water environment

New plans drawn up by the Scottish Environment Protection Agency, designed to improve the environmental quality of rivers, lochs and seas, have been approved by Scottish ministers. The River Basin Management plans will provide improved benefits for wildlife and tourism sectors in Scotland by introducing measures to help cope with the impact of climate change. More than 100 stakeholders were consulted regarding the proposals.

Tree planting scheme for North Hampshire

The Forestry Commission has started work on an extensive winter conservation project to plant more than 50,000 new trees at the Crowthorne and Bramshill Forests in north Hampshire. The work will form part of a wider scheme across South East England to plant more than 250,000 trees in a bid to improve sustainable forestry. Plans include 10,000 Scots Pine trees for Crowthorne Forest and a further 40,000 earmarked for Bramshill Forest.

Nature reserve status for WWII base

Skipwith Common regarded as one of the UK's "best examples" of lowland heath

Natural England (NE) has confirmed that Skipwith Common, Yorkshire, which is home to a former Second World War bomber base, has been designated as a National Nature Reserve.

The 274-hectare (677-acre) site, which is situated within the Escrick Park Estate, is already recognised as a Site of Special Scientific Interest and a Special Area of Conservation.

Part of the site, which boasts dry and wet heathland and rare plants, dragonflies and other invertebrates habitats, was used during the Second World War as an airfield to train Halifax bomber crews.

The site's designation also helps to mark the 60th anniversary of the 1949

National Parks and Access to the Countryside Act – the legislation which led to the creation of National Nature Reserves and National Parks.

NE chair Poul Christensen said: "An immense amount of work has gone towards ensuring that this much-loved landscape remains both a haven for wildlife, and a place that everyone can enjoy.

"Skipwith Common is one of the best examples of lowland heath in the north of England and this declaration is a fitting way to mark the 60th anniversary of the Act that first brought National Nature Reserves into being."

Conservatives pledge to preserve national parks

The Conservative Party has announced that it will "strongly" support National Parks across the UK if it wins this year's general election.

Speaking on a live web chat on the *Guardian*'s website, shadow environment secretary Nick Herbert said that the party was "committed" to the parks, which include the Lake District, the Brecon Beacons, the Pembrokeshire Coast and the New Forest.

In response to a question from one "cwestney", who asked what the Conservative Party's policy on funding for the UK's National Parks was, Herbert replied: "National parks protect our most precious landscapes. They're vitally important areas and we need

to continue to give the parks our strong backing.

"I recently signed a [House of] Commons motion marking the 60th anniversary of the creation of National Parks and pointing to the challenges and opportunities they face, including tackling and adapting to climate change, helping provide affordable housing for local people, and supporting a diverse and successful rural economy that sustains these landscapes.

"You probably won't be surprised to hear that in the current economic climate I can't make any pledges about funding in any Defra area, but I hope this makes our commitment to the parks clear."

Six firms make Stoke street revamp shortlist

▶ Stoke-on-Trent City Council has announced that six design teams have been shortlisted to lead plans for a multi-million pound refurbishment of the city's public squares and streets. Aecom: BDP: Camlin Lonsdale Landscape Architects; Gillespies; Nicholas de Jong Associates and Planit are the firms to be selected to draw up detailed plans as part of a wider £1.5bn transformation of the area.

Green light for £50m Liverpool library plans

▶ Plans for the major £50m refurbishment of Liverpool's Central Library - which is one of the UK's largest library developments - have been given the go-ahead by planners at Liverpool City Council. A temporary library will be established in Liverpool city centre while the two-and-a-half year Central Library scheme is carried out by Inspire Partnership, a joint venture including York-based Shepherd Construction and London-based Amber Infrastructure.

Council seeks Maidenhead views

Residents are being invited to comment on a new masterplan for the future regeneration of Maidenhead town centre drawn up by the Royal Borough of Windsor and Maidenhead, A four-week consultation into the draft Area Action Plan is set to launch on 18 January to gather views on a range of proposals for the Berkshire town, which could include a new concert or conference venue and new waterside walks.

Liverpool set for £200m development

Framework for major leisure and retail scheme approved by city council planners

Liverpool's Edge Lane Central area is set to undergo a major £200m transformation under new plans drawn up by landowner Derwent Holdings. Liverpool City Council (LCC) and Liverpool Vision.

A development framework for the 28-hectare (69.2-acre) site, which includes plans for a 600,000sq ft (55,742sq m) leisure and retail space, was put before LCC's executive board on 15 January for approval.

The Edge Lane Retail Park, the former Ian Skelly Car Showroom site and Rathbone Road Recreation Ground are among the sites incorporated in the proposals, which include a new community park.

Local businesses, residents and community groups will be

consulted on the plans once the development framework is approved by LCC, which will also see improved pedestrian links as part of a phased programme of work

LCC leader Warren Bradley said: "What we are looking at is a comprehensive redevelopment and now we can embark

on a new future – and not just for people passing through the area. We will have a much improved retail offer which will act as a catalyst for regeneration in this area.

"And there will be much improved leisure facilities and green spaces for the benefit of the local community."

HNG expands leisure team

Chartered surveyor Hargreaves Newberry Gyngell (HNG) has expanded its operations by merging with Londonbased leisure specialist, Intrinsic Property.

The directors and staff of Intrinsic Property have joined HNG at the head office in Wigmore Street to build upon HNG's existing leisure team.

Battersea plans receive backing

Developers behind the latest plans for a £5.5bn mixed-use redevelopment of Battersea Power Station in London have reported an increase in local support for the scheme.

Real Estate Opportunities and Treasury Holdings UK said that more than 80 per cent of visitors to a third public exhibition held in December supported architect Rafael Viñoly's masterplan for the site.

The proposals, which have already been submitted to Wandsworth Council, boast 700,000sq ft (65,032sq m) of restaurant and retail space, a

Time to ask for smart presents

The government will listen – if it likes what it's hearing

The are fast approaching the countdown for the election with every trade association and Government-funded agency worth its salt busily preparing a manifesto for what it wants the oncoming government to do for its organisation.

It's a bit like writing a Christmas letter to an unfriendly Santa – you explain how good you've been all year (for the economy/employment/social policy outcomes) and present a wish list of initiatives that you'd like Santa to reward you with. In the back of your mind, however, there's the nagging thought that Santa is as likely to nick your toys as he is to deliver new ones.

This time that worry is heightened by the knowledge that there will be very few presents for Santa to distribute. Therefore our sector needs to play smart. Only by presenting initiatives that make savings will we be listened to.

Here's an example of an initiative that provides tourism benefits while saving the government money. In overseas markets such as India and China the UK Border Agency (UKBA) has outsourced the new biometric visa processing centres. The use of these facilities could be shared with other European countries who also have biometric visas. This would reduce UKBA costs while the tourism sector would benefit as visitors to Europe would only need to present themselves once to get both a Schengen and a UK visa. If such a move only produced a 5 per cent increase in visitors, that's £150m extra in foreign revenue for the UK!

2009 boom for Scottish tourism

ONS figures show an increase in Scotland's share of UK visitor numbers

New figures from the Office for National Statistics (ONS) have shown that Scotland outperformed the rest of the UK by increasing its share of overseas visitors between July and September 2009.

Compared with the same period in 2008, Scotland reported a 25 per cent increase in visitors from North America and a 43 per cent increase in visitors from countries outside Europe and North America.

As a whole, the UK posted a 6 per cent increase in visitors from North America and a 1 per cent increase from countries outside Europe and North America during the three-month period.

Scottish tourism minister Jim Mather said: "These figures underline the success of Homecoming 2009, which proved to be an exceptional year with events being heavily promoted throughout the world.

The City Centre Management Strategy 2009-14 outlines three key objectives, including the creation of an infrastructure to attract inward investment, to encourage more visitors to the city centre and to develop a unique sense of identity and experience for Liverpool.

Britons shun winter breaks for summer holidays

One in five Britons has cancelled plans for a winter holiday and are instead saving for a summer getaway.

Research by PricewaterhouseCoopers (PwC) claims the recession has caused a shift in booking patterns and a decline in the people taking winter holidays.

From more than 2,000 people polled, a fifth more this year (2009-10 when

compared to 2008-09) are forgoing their usual winter break.

PwC leisure director David Trunkfield, said: "Skiing is perceived as a niche and luxury holiday and decision making will be affected by euro and swiss franc exchange rates.

"These winter breaks which act as a second holiday remain under pressure."



New £30m community sports hub for Warrington

Warrington Borough Council has given final planning permission for the £30m Orford Park Project.

Billed as one of the UK's first sustainable community sports hubs, the centre will be located in a Super Output Area already regarded as an example of best practice in joint service delivery, health and wellbeing.

The centre will provide a variety of community, health and education facilities including a community sports village complete with pools, a sports hall, a health and fitness suite, football pitches, a library, a health centre, and a £3.9m 14-19 Diploma Centre.

Orford Park will be funded by the Northwest Regional Development Agency, Sport England North West Region, the Football Foundation, the Big Lottery Fund and the Department for Children, Schools and Families (DCSF) through BSF. Funding for the Diploma Centre has also been allocated by DCSF through its Exemplar Diploma Initiative.

Historian launches Staffordshire Hoard campaign

A campaign has been launched by historian Dr David Starkey to help raise £3.3m to keep the Staffordshire Hoard - the largest amount of Anglo-Saxon gold ever found in the UK - in the West Midlands.

The fundraising appeal has been launched with an initial grant of £300,000 from the Art Fund, while Birmingham City Council and Stoke-on-Trent City



The hoard was found last July

Council have both already agreed to contribute £100,000 to take the sum already raised to £500,000.

Discovered in July 2009 by metal detectorist Terry Herbert, the Staffordshire Hoard is a collection of more than 1,500 Anglo-Saxon artefacts dating back to the 7th century.

However, the Art Fund-led campaign has until 17 April to raise the £3.3m needed to save the hoard, which will be put on display at the Birmingham Museums and Art Gallery and the Potteries Museum and Art Gallery in Stoke-on-Trent.

Lundy awarded MCZ status

The waters around Lundy Island – off the coast of Devon – have become England's first Marine Conservation Zone (MCZ) under the new Marine and Coastal Access Act.

The new network of MCZs is designed to protect England's marine species and habitats, from the common to the rare and threatened.
