'Dormant millions' to help enhance sports facilities

By Tom Walker

The government is to explore the possibility of using abandoned betting accounts and other unclaimed winnings to benefit good causes.

John Penrose, minister for tourism and heritage said: "There is potential for some really good causes to benefit from this money - but we have to look at all the options first. That's why I've asked Don Foster to lead this review and leave no stone unturned.

"Every day thousands of people bet on the outcome of sporting events. Therefore it seems a natural fit that funds from abandoned betting

accounts should benefit grassroots sports projects."

Foster, the Liberal Democrat MP for Bath, has been tasked with compiling a report into how much money would be

involved, as well as determining how a betting account can be classified as dormant and clarifying any legal ramifications surrounding the potential use of the money.

"I'll be meeting representatives from all parts of the industry throughout the autumn to gain views and suggestions on how this can work," said Foster.

"It would be great to see some local sporting facilities and initiatives getting some extra funding in these difficult financial times."

The review stems from a pledge set out in the Coalition Agreement to look into the best use of abandoned betting accounts. Foster will present his findings – along with a possible proposal of new legislation - to by the end of the year. Once the report has been considered a consultation will follow.

Deeside Leisure Centre to receive £4m renovation

Alliance Leisure appointed by local council to manage extensive redevelopment

Flintshire County Council has appointed Alliance Leisure to manage a £4m redevelopment of Deeside Leisure Centre.

An 80-station family fitness zone will be created through the conversion of an old first floor nightclub as part of the scheme, which will boast free weights, Technogym resistance and cardiovascular equipment, along with two studios and new changing rooms.

A Shapemaster Feel Good Factory toning salon, featuring

both Powertone tables and Easytone chairs is also planned.

The new gym will form the second stage of a three-phase refurbishment programme at Deeside Leisure Centre. The first phase, which is due to be completed by October, includes six five-a-side, 3G football pitches, a roller hockey zone and a multi-use games area.

The third phase of the project will see the rejuvenation of the old ice rink and the creation of an indoor extreme sports facility housing a climbing wall, high ropes course and a skate park for boarding, inline skates and BMX bikes.

Plans also include a new soft play zone for small children.

Expansion plans for Tate St Ives

Tate St Ives, the Cornish branch of the Tate art gallery, is to go ahead with expansion plans after securing a deal to acquire land from Cornwall Council and the Penwith Housing Association.

New gallery spaces and art handling facilities will enable Tate St Ives to provide a more ambitious mixed programme of St Ives and national collection displays, alongside national and international exhibitions.

2012 chiefs launch volunteer scheme

Games Makers to perform a range of specialist and general roles during the event

Up to 70,000 volunteers are to be recruited in order to fill a number of roles at the London 2012 Olympic and Paralympic Games, under plans unveiled by the Games' organisers.

Games Makers will be trained by fast food restaurant chain and 2012 partner, McDonalds. Pre-identified applicants for specialist positions, such as sport or press operations, will be able to apply from 27 July.

Applications for general volunteer roles – spectator assistants, ticket checking and uniform distribution – are set to open on 15 September, while up to 1,500 under 18s can apply for the Young Games Maker programme in 2011.

Meanwhile, mayor Boris Johnson's bid to recruit London

Volunteers, which will be placed at transport hubs, on the city's streets and at attractions during Games time to 'welcome' visitors, will open to applicants from 27 July.

London 2012 organising committee chair Sebastian Coe said: "Our volunteers will be called Games Makers to reflect

the important role they will play in staging the 2012 Games."

Steve Easterbrook, chief executive of McDonalds UK, added: "It is our ambition to ensure that the 2012 Games volunteers are also highly valued, recognised and celebrated for their efforts and achievements."

CCPR broadcasting code to be reviewed

Sports minister eyes increase in minimum reinvestment from sale of television rights

Sports minister Hugh Robertson has revealed that the Central Council of Physical Recreation (CCPR) is to review its voluntary broadcasting code to boost grassroots sports.

Under the current terms of the code, national governing bodies (NGBs) agree to reinvest a minimum of 5 per cent of revenues gained from the sale of broadcast television rights for major events.

However, Robertson believes the code should be changed so that NGBs – including the Football Association and the England and Wales Cricket Board – reinvest a minimum of 30 per cent in grassroots sports.

While the review will focus on the contribution of NGBs, other signatories including the

Premier League and golf's PGA European Tour will also be given consideration in a bid to further boost grassroots.

Robertson said: "National governing bodies have a duty to ensure that they have the strongest community structure possible. A thriving grassroots

is only going to help the sport at the top end."

CCPR chief executive Tim Lamb added: "All signatories reinvest significantly more than 5 per cent, but a potential increase to 30 per cent would provide even more of a quarantee for grassroots sport."

New Trifitness facility set for Scottish Borders

Borders Sport and Leisure Trust has teamed up with Heriot-Watt University and Borders College to create a fitness centre for the Scottish Borders.

Technogym signs London 2012 deal

▶ London 2012 organisers have confirmed that Technogym will provide and install fitness equipment at the Athletes' Village and other training venues at the Games. The firm has been named as a Tier Three supplier, with more than 750 pieces of equipment due to be installed at several gyms within venues in addition to the main gym at the Athletes' Village. Technogym will be responsible for the design and layout of gyms, while also providing maintenance and staff services in its role as Official Fitness Equipment Supplier.

Companies 'missing the fitness trick'

Majority of SMEs have no schemes to encourage staff to become gym members

New research has revealed that two thirds of UK small and medium enterprises (SMEs) in the leisure industry have no schemes in place to encourage staff to exercise or eat healthily.

Finance provider GE Capital found that more than half - 54 per cent – of SME owners or managers believe the provision of free health checks could make a difference in promoting healthy workplaces.

Only 25 per cent of businesses have implemented schemes designed to encourage exercise and healthy eating while less than one in ten encourage workers to take a lunch break. GE Capital interviewed 500 SME owners and managers as part of the research, with nearly a fifth of businesses reporting a loss of at least 25 days each year due to staff-related health issues.

Nearly 30 per cent of firms do not think anything can be done to change the support they currently provide to employees, while 19 per cent believe more information should be provided to help implement such schemes.

John Jenkins, chief executive officer at GE Capital, said: "Against a backdrop of growing pressure on NHS budgets and a

need for SMEs to drive economic growth, anything that can be done to enable SMEs to invest more to promote a healthier lifestyle amongst their employees has got to make economic sense.

"Healthy workplaces will result in a higher level of productivity, while minimising any health insurance costs that small firms may have."

The move means that the facility has become one of the UK's largest independent centres for physical excellence and personal training.

Inactivity 'caused by weight problems'

Study claims that emphasis on exercise will not improve childhood obesity levels

Lack of exercise is not a major cause of childhood obesity, according to an 11-year research into child health.

Although the study of more than 200 children in Plymouth did find that obese children are inactive - it concluded that the inactivity is the result of the weight problems, not a cause.

The study, conducted by the Peninsula College of Medicine and Dentistry, looked into whether physical activity of children precedes changes in fatness over time, or whether the fatness of children precede changes in physical activity over time.

According to the report, "It is well known that less active

New Battle of Britain centre proposed

▶ The Battle of Britain Memorial Trust has announced plans to create a new £650,000 learning centre at Capel-le-Ferne, Kent, dedicated to Allied aircrew. Film, walkthrough displays and modern technology will be used to create a 'living history resource' as part of the proposals, unveiled to coincide with the 70th anniversary of the World War Two battle. It is hoped that the facility will be built close to the existing Hunting Lodge shop and refreshment area, with a feasibility study having already confirmed the project's viability.

£425,000 revamp for Arbroath museum

Angus Council has announced that the Signal Tower Museum in Arbroath, Scotland, has closed to undergo a £425,000 revamp. Due for completion in spring 2011, the scheme will include the creation of new displays exploring the town's maritime heritage and its link with the Bell Rock Lighthouse. The Signal Tower has housed the councilrun museum since 1974, having previously provided a shore base for the historic lighthouse.

Kuwaiti cash boost for Dorset tank museum

The Tank Museum in Bovington. Dorset, has received a £1.5m donation from the Kuwaiti government in a bid to recognise the role played by the Royal Armoured Corps during the Gulf War. Among the Tank Museum's collection is a Challenger 1 tank, which was one of the first to cross the Kuwaiti border from Saudi Arabia in February 1991 in the wake of Irag's incursion into the country. The museum will now rename its outdoor tank arena - built as part of a £16.5m redevelopment completed in 2009 - as the Kuwait Arena.

Sea City Museum contractor chosen

Kier Southern revealed as council's preferred contractor for £15m development

Southampton City Council (SCC) has selected Kier Southern as its preferred contractor to construct the city's new £15m Sea City Museum.

However, the final appointment of the contractor – part of the Kier Group – remains subject to the approval of SCC's cabinet at the end of August.

Forming part of Southampton's wider Cultural Quarter development, Sea City Museum will be housed in a converted Grade II*-listed Magistrates' Court adjoining the Civic Centre.

Two permanent galleries will explore the city's status as a 'Gateway to the World' during the last 2,000 years and its relationship with the ill-fated liner *RMS Titanic*, which claimed 549 local lives.

Southampton's range of archaeological and maritime

exhibits are to be put on show at the Wilkinson Eyre Architects-designed attraction, which will also feature space for temporary exhibitions.

The Heritage Lottery Fund has already contributed £4.6m towards the scheme, with work expected to start on site in October. Gifford, Davis Langdon and Urban Salon are also involved with the project.

SCC cabinet member for leisure, culture and heritage John Hannides, said: "The appointment of Kier brings us one step closer to the realisation of the Sea City Museum that will showcase Southampton's maritime heritage."

Sea City Museum is scheduled to open in 2012, coinciding with the 100th anniversary of the Titanic's sinking.

HLF boost for Wearside museum

Monkwearmouth Station Museum in Sunderland, Tyne and Wear, has been handed £92,000 from the Heritage Lottery Fund (HLF) to help fund a project to restore railway wagons and sidings.

Two of the attraction's key items – a covered carriage truck built in 1939 and a goods brake van built in 1915 – will be the focus of the scheme, with the wagons to be moved to a new purpose-built building.

The provision of more learning resources for young people also forms part of the scheme, which will open up the museum to a wider audience.

Monkwearmouth Station

Museum – managed by Tyne

and Wear Archives and Museums on behalf of the local authority – is housed in a Grade II*-listed former station built in the 1840s.

Ivor Crowther, head of the HLF in the North East, said: "These carriages and the museum give us a great insight into the North East's rich travel and transport history."


NMW to fight for free admission

National Museum Wales (NMW) has said that it will continue to fight to ensure that its attractions carry on offering free admission to the public, despite the recent budget cuts.

Last year was nearly its best year on record, second only to its centenary in 2007.

NMW director general Michael Houlihan, said: "It's nearly a decade since the Welsh Assembly Government made a commitment to fund free entry to our seven national museums.

"The recession has seen an increase in visitors to our museums, so there is an even greater demand for our services, particularly from those people who are most affected by the economic downturn."

Skills area for mountain bike centre

A new skills area has been added to the Coed Llandegla mountain bike centre in Wales. The new Skills Trail, one of the first of its type in the UK, offers a safe place for mountain bikers of all ages and abilities to learn new techniques and build confidence before setting out on the trails at Coed Llandegla. The area, which covers 600 metres of trail and includes several jumps. will also be used for mountain bike training courses. The Coed Llandegla centre is operated by Oneplanet Adventure.

New trust to run Aberdeen facilities

▶ Aberdeen City Council has confirmed that it has transferred the operation of its sports facilities to leisure trust Sport Aberdeen for a 10-year period. The Sports Trust Project Board/Working Group has met regularly over the last 18 months in order to oversee the process, which aims to help the local authority meet strategic and financial objectives. Sport Aberdeen is expected to play an integral part in delivering a new physical activity strategy for the city, as well as increasing participation and promoting Aberdeen as a tourist destination.

Green light for Telford sports plans

▶ A new sports and learning community is to be developed in Telford after the local authority agreed a deal to build the facility on land off Salisbury Avenue. Telford and Wrekin Council is behind plans for the Priorslee Sports and Learning Community, which will replace Wrockwardine Wood Arts College and will cater for 1,050 pupils. The proposed facility will adopt Wrockwardine Wood Arts College's status as a centre for performing arts.

2010 organisers confirm £27m savings

Latest report quarterly savings take total amount of cost reduction to £700m

Preparations for the 2012
London Games remain on
course despite the government's
decision to reduce the Olympic
Delivery Authority's (ODA)
budget as part of wider efforts
to reduce public spending.
Organisers have confirmed that
£27m worth of savings have
been made in areas including
construction site security and
the media venues, as well as
smaller alterations to the
Basketball Arena and Velodrome.

The latest London 2012 Olympic and Paralympic Quarterly Economic Report also revealed that the Games' anticipated final cost has been cut by £6m to £7.261bn, compared with last month.



Small alterations have been made to venues such as the Velodrome

According to the ODA, more than £100m has now been saved during the last quarter and around £700m since the baseline budget was agreed in November 2007, which have helped offset increases in other areas. Hugh Robertson,

minister for sport and the Olympics, said: "This report shows they have delivered £27m of savings as part of the government's measures for reducing the deficit while keeping the whole Olympic programme intact."

ASA 'disappointed' over government's swim axe

The Amateur Swimming Association (ASA) has expressed disappointment at the government's decision to withdraw £25m of funding set aside for the upgrade of swimming pools.

Sport England was due to distribute the cash on behalf of the Department for Culture, Media and Sport and the Department for Education towards a total of 44 council

and school pool projects. The government has, however, now decided to axe the

funding as part of a bid to reduce public expenditure and tackle the national deficit; a move the ASA admitted it had been expecting.

ASA chief executive David Sparkes said: "The way forward now is to see how the modernisation of pools can be continued with no commitment to government funding. This will be a challenge but we will continue to work with pool operators and local authorities on the best way to do this."

New strategy for installations of artificial pitches

Sport England, the Football Foundation and four national governing bodies have reached agreement over a new strategic approach for the selection of artificial sports pitches.

New guidance drawn up by the governing bodies of football, hockey, rugby union and rugby league will help ensure that correct surfaces are installed in the right places and provide maximum value for investment. Each of the four organisations have committed to using the new approach, which has been drawn up after it was revealed that not all artificial surfaces are able to meet the needs of local communities.

Billingham Forum scheme a step closer

Redevelopment of leisure venue designed to 'future proof' facility for next 30 years

A major £17m renovation of Billingham Forum, Stockton-on-Tees, has reached a milestone following the completion of internal infrastructure work and exterior improvements.

Stockton Council's bid to transform the 1960s venue into a new sports and leisure complex has encountered delays due to the poor weather conditions earlier this year and the removal of asbestos.

Warwickshire-based contractor Morgan Sindall is four months behind schedule with the project as a result of the delays, although it is now hoped that Billingham Forum will be able to reopen in spring 2011. A six-lane, 25m swimming pool with a new training

pool and retained learner pool will be among the facilities at the complex, along with an extended 70-station gym and an upgraded ice rink.

Improvements to Billingham Forum's theatre area, the four-court sports hall, two squash courts and reception area also form part of the project, as well as the creation of a children's play barn and function room.

The redevelopment has also been designed to 'future proof' the sports venue for at least 30 years; five more years than originally anticipated.

Morecambe FC stadium opening delayed

► Morecambe Football Club (MFC) has cancelled three pre-season friendly fixtures after the opening of its new Globe Arena venue was delayed until early August. Delays in the final stages of construction at the £12m venue, which will be capable of accommodating 6,000 spectators, now means the handover of the stadium has been put back to 6 August. The Globe Arena has been developed on a 5.3-hectare (13-acre) site in the town's Westgate area by Warringtonbased Globe Construction, which has signed a five-year sponsorship deal with the League Two club.

New 'Games for Scotland' launches

EventScotland and the Scottish Government have launched a new project designed to engage local communities ahead of the 2014 Commonwealth Games in Glasgow. The £320,000 Games for Scotland programme aims to raise awareness of the Handover Ceremony taking place in Delhi, India, later this summer and will feature a number of sporting and dance events. A mini Commonwealth Games event is to be held in the Shetland Islands as part of the initiative, which will involve all 32 Scottish local councils and aims to bring together people from across the country.

Sport Unlimited achieves landmark

Nearly 500,000 young people have taken part in Sport Unlimited, a programme aiming to get more youngsters playing sport outside of school. Since its launch last year, thousands of activities have been delivered across a wide range of traditional and less well-known sports including football, climbing, skiing, kayaking and parkour.

Grant for street sports

A pilot project promoting street sports in Newmarket is set to become a permanent fixture after the initiative received £20,000 worth of funding from the Western Suffolk Community Safety Partnership.

The scheme, called
Street Football, was
launched on 7 May by
Anglia Community Leisure,
the trust that operates
leisure facilities in Forest
Heath on behalf of the
council. The project aims
to offer young people
physical activities as part
of plans to reduce
anti-social behavior.

Keiran Williams, project leader, said: "We want to give young people something to do in the evening through sport."

Whitbread unveils green revamp drive

Whitbread will be spending more than £7m this year in a programme designed to boost the environmental performance of its hotels, restaurants and coffee shops. The move will help the group deliver against its targets of a 26 per cent reduction in energy consumption and a 20 per cent reduction in water use by 2020. As part of the scheme, 20,000 low-flow showerheads will be installed at Premier Inn hotels, an initiative calculated to save enough water to fill 88 Olympic swimming pools a year by 2012.

Punch Taverns reports World Cup sales boost

▶ Pub group Punch Taverns has revealed that this summer's World Cup has helped increase like-for-like sales at its managed estate during the 44 weeks ending 26 June 2010. The company said that the good weather in May and June had helped offset losses incurred as a result of inclement conditions in early 2010, while it remains on track to meet expectations for the full year. However, Punch Taverns has warned of "uncertain" conditions that still face the industry, with the government's decision to keep the beer duty escalator despite a proposed increase in VAT.

Former MoD offices to become Liverpool hotel

▶ A former Ministry of Defence office building located in the centre of Liverpool, is set to be transformed into a new 154-bedroom Days Inn hotel. Sanguine Hospitality Management Company will own and operate the new Days Inn Liverpool hotel, which is due to open in February 2011 and is poised to occupy all five floors of the Moor House site.

Industry calls for 'fairer' alcohol rules

Seven sector associations urge the government to introduce a "level playing field"

Seven of the UK's largest industry bodies have called on the government for a "fairer" tax and regulatory system to deal with the sale of alcohol.

In a speech to the Westminster Food and Nutrition Forum, British Beer and Pub Association (BBPA) chief executive Brigid Simmonds highlighted the need for a "level playing field" to be introduced between the sector and retailers.

According to the BBPA, 70 per cent of alcohol is sold by supermarkets and is undermining efforts to tackle misuse and anti-social behaviour, while also threatening industry jobs.

The British Hospitality Association; the British Institute of Innkeeping; the Federation



The associations have called for more support for the industry

of Licensed Victuallers Associations; Business in Sport and Leisure; Noctis; and the Association of Licensed Multiple Retailers have all joined forces with the BBPA.

Among proposals submitted is a review of the Licensing Act, banning the below-cost selling

of alcohol and improved incentives for businesses to boost trading practices.

Simmonds said: "We need to rebalance our system to ensure everyone who sells alcohol is equally responsible and that greater emphasis is placed on the accountability of individuals."

Ricoh Arena in De Vere tie-up

A 71-bedroom hotel at Coventry's Ricoh Arena is set to benefit from a £1m transformation after the stadium secured a tie-up with De Vere Venues.

The agreement will see the revamped hotel adopt the De Vere brand and will be extended to offer additional rooms. It will continue to be operated by the Compass Group.

A 5,000sq ft (464.5sq m) training suite catering for up to 5,000 delegates will also be created.

It is anticipated the partnership will allow the Ricoh sales and management team to tap into De Vere Venues' £300m annual pipeline, with the hotel revamp due for completion later this year.

Boutique chain Hotel Indigo – owned by InterContinental Hotels Group (IHG) – has continued its UK expansion plans with the opening of a new London property.

Facilities at the eight-storey hotel include a bar and two restaurants, with views overlooking Tower Bridge available from the upper floors. It is the second Hotel Indigo to open in the capital.

The Hotel Indigo brand currently operates 34 properties worldwide, with a further 53 planned; four of which will be located in the UK. The first site to open in the capital was in Paddington in January 2009.

Travelodge buys 52 M&B hotels

Budget hotel chain Travelodge has acquired 52 Innkeeper's Lodges from restaurant and pub operator Mitchells & Butlers (M&B). The deal – equating to 1,994 rooms – will increase Travelodge's estate to 452 hotels and its room stock to 30,504 across the UK, Ireland and Spain.

The 52 hotels include a number of grade II listed buildings, range from 21 to 85 rooms and are adjacent to an M&B restaurant and pub. The £91m deal saw the hotels sold to Prupim, a property investment arm of Prudential, which has leased the hotels to Travelodge for a 25-year term.

The company will now undertake a £10m investment programme to bring them in line with the Travelodge brand, a move which will include building new reception areas, replacing all the beds and decorating the hotels.

The hotels will be rebranded within four months.

eaving the BHA after ten years was always going to be a wrench but there's no doubt that this year was a most opportune time to quit - when a new government is in place which, I devoutly hope, will take the tourism and hospitality industry – worth more than £115bn annually - far more seriously than it has been taken in all the 13 years of the last administrations.

That can only be good. Of course, the industry won't get all it wants but I know that the BHA's arguments will be positive, forward-looking and clearly designed to meet the many future challenges which will inevitably be presented.

The hospitality industry has made great strides in the last ten years – I've no doubt that there will be similar progress in the future. It has survived enormous challenges, largely by its own efforts: the foot and mouth outbreak in 2001, the attack on the twin towers in the same year, the London bombings, and, more recently, the economic recession which still concerns many operators.

I wish the association the greatest good fortune. I am sure it will drive the industry forward and advance its interests to the advantage of everyone – employer and employee alike. And I know that the industry will give Ufi the level of support that it has so generously given to me – and that she, too, will find she has the best job in hospitality.

London hotels set for double-digit growth

London hoteliers remain "on track" to post double-digit revenue per available room (RevPAR) growth in 2010, according to new figures from advisory firm Deloitte.

During the first half of the year, the capital's hotel operators reported a 9.3 per cent increase in RevPAR, driven by a 7 per cent

growth in average room rates. Occupancy increased by 2.1 per cent.

Meanwhile, regional hotel operators have seen occupancy grow by 4.2 per cent during the first six months of the year, which comes after Q1 brought an end to seven successive quarters of decline.

Newport resort owner slams local authority

▶ Sir Terry Matthews, the owner of the Celtic Manor Resort in Newport, South Wales, has revealed that he will no longer invest in the city after councillors rejected plans to relocate a listed farmhouse. Plans put forward by the resort - due to host the Ryder Cup later this year - would have seen the 17th century Little Bulmore structure moved to a new site but were rejected by Newport City Council's planning committee. Officers had advised committee members to approve plans for the Grade II-listed farmhouse sited near the resort's golf course, although Sir Terry told the BBC that the decision was a "slap in the face".

Work starts on new **Hull vouth centre**

▶ Hull City Council (HCC) has announced the start of construction work on the city's new youth centre, which will replace a former church hall on St George's Road. Network -Young People's Centre will be able to accommodate more than 1,500 young people and will include a café; media and arts spaces; a sports area and an external performance area. Hobson and Porter has been appointed to deliver the Salt Architects-designed venue, which will also provide alternative learning services. Hessle Road Network will manage the facility. More than £1.2m has been raised to cover the cost of the project, with funding sources including the Youth Capital Fund Plus, HCC and Hull Forward, as well as Hull Primary Care Trust and Biffa.

McLaren to deliver new THFC facility

"The appointment of contractors for the main building is a key step in the progress of the development and we look forward to McLaren working with us."

Severn Trent to offload Vyrnwy

A 23,315-acre (9,435-hectare) estate surrounding Lake Vyrnwy in Wales, which incorporates a nature reserve and a number of conservation areas, has been put up for sale.

Severn Trent Water is looking to offload a 125-year lease to one of the largest single blocks of land to be sold in England and Wales in recent years.

A guide price of £11m for the lease has been set by agent Knight Frank, with the sale split into four lots; the largest of which covers a 12,000-acre (4,856-hectare) site farmed jointly with the RSPB.

Sales up at Premier Training

48 per cent increase in interest in fitness courses

Training provider Premier
Training International (PTI) has reported a 48 per cent increase in the number of people that have applied to study for health and fitness qualifications.

The company, which offers NVQ courses at Levels Two and Three, has trained more than 5,000 people through entry level diplomas in the last two years, with a 95 per cent success rate over the past 12 months. According to PTI, the growth in applicants is due to the expansion of the

sector's job market and an increase in the number of local authority and PFI fitness facilities now available.

PTI chief executive officer Debra Stuart said: "We put the increase in demand for our courses down to the fact that the health and fitness sector has proven to be virtually recession proof.

"16-24-year-olds make up the majority of our course applicants but there are older students too and those looking to retrain after either changing careers or exiting the armed forces or emergency services."

Football club to offer qualifications

Blackburn Rovers Football Club has teamed up with Myerscough College in Preston, Lancashire, to offer an academic qualification for young girls who are leaving school. The initiative has been designed to enhance career opportunities for talented female footballers.

Myerscough College tutors will deliver two courses at the football club's Indoor Centre at Ewood Park – a first diploma and a national diploma in football studies.

The courses will utilise the on-site facilities and resources, which include two designated classrooms, two indoor pitches and an IT suite.

The partnership focuses on providing the girls with a football coaching qualification, while offering them the possibility of progression to play in the Blackburn Rovers Ladies first team.

The changing face of the playwork sector

We need to ensure that people in the play sector have the right skills and qualifications

ver the last few years we have experienced a step-change in the way the playwork sector approaches training and qualifications. Sector employers have embraced the move toward a professionally qualified workforce, and there's been a change in perception of the sector. Playwork is beginning to become recognised as an industry with real career options.

Playwork is a highly skilled profession that enriches and enhances children's play. It takes place where adults support children's play, but it is not driven by

prescribed education or care outcomes. As with all our sub-sectors, our role is to improve the quality and range of play opportunities for children and young people through the professional development of the playwork workforce. With the introduction of playwork-specific national occupational standards, the Qualifications and Credit Framework, and various bursary schemes relating to higher level qualifications for the sector, we are certainly driving professionalisation. However, recent results from our Playwork People 4 survey suggests that playwork sector employers are still struggling to find the staff they need with the right skills. A staggering 60 per cent of employers surveyed stated that they do not have all the skills they need across their workforce to run their business as they would like. When asked what skills were lacking in their workforce, a 'knowledge of the playwork values and principles' was top of the list. This may be caused by the fact that 44 per cent of playworkers do not have a playwork specific qualification.

These results are telling. No matter how much the sector has moved on, unless we get the messages out there, the workforce is still not seeing our sector as a viable career option and this is a huge challenge. One of the key developments for the sector was the publication of the first ever UK strategy for playwork, Quality Training: Quality Play. For the very first time we had a UK-wide approach to the development of playworkers and the beginnings of a recognition and support for the playwork profession within Westminster and the devolved administrations. That strategy runs until 2011, and following the recent change in government and its subsequent review and revision of policies, it is timely that we have been consulting on a new strategy for the sector which is due to be published in the autumn and will run until 2016.

The new strategy will refocus the sector's attention on workforce development and the need to have more people, better skilled, better qualified entering and progressing, a career through the sector. It will give particular emphasis on giving the sector the professional recognition and support it needs.







Aerial Extreme already runs four courses – Bedale, North Yorkshire; Knowsley Safari Park, Merseyside; Trentham Estate, Staffordshire; and Willen Lake in Milton Keynes.

Sinan Osman, managing director of Aerial Extreme, said: "We have been keen to bring Aerial Extreme to a big city like Sheffield for some time.

"The course we have developed is tailor-made for Sheffield and having it situated right in the heart of a city makes it much more accessible for adventurers of all ages."

Oatlands' co-owner John Tostevin, said: "We have run the business successfully for 13 years and it is now time to move on to other interests."

A new club development fund will be launched by the Football Conference after receiving a £6m "solidarity package" from the Premier League.

The funding will be split into general payments – £1.2m shared among the 68 competing clubs each year – and £800,000 to be made available through the new fund.
