# **Your Leisure opens new Ramsgate Swim Centre**

Thanet District Council (TDC) and leisure trust, Your Leisure, have opened a £4.1m swim centre as part of the development of the Ramsgate Sports Centre in Kent.

The Ramsgate Swim Centre will be operated by Your Leisure and includes a 25-metre pool, spa and a Feel Good Factory toning studio.

Your Leisure acquired development funds for the scheme through private sector partner Alliance Leisure. It plans to repay the money over time through increased commercial opportunities brought about by the new spa, while also making

savings in other operating departments – ensuring there will be no additional cost to TDC.

The new centre is conneted to the existing Your Leisure-operated Ramsgate Leisure Centre, to create one joint facility.

The development sees the introduction of a 25-metre swimming pool, as well as a smaller pool for children and swim lesson programme.

Your Spa is a purpose-built luxury wellness environment which includes thermal experiences, a hydro spa pool and four treatment rooms. The toning suite has 12 stations, while updates have been made to the existing fitness suite, a new cafe added and changing rooms modernised.

Paul Cluett, commercial director of Alliance Leisure says: "Our approach in Ramsgate was to replace a non-viable facility, while redeveloping the council's leisure and sports building stock with a focus on creating new revenue streams and lowering running costs.

"This project shows how services can be improved,

without increasing revenue demands on councils.

"There are 100 pools in the UK near the end of their useful life. Many are near dry sports centres and in such cases, councils could rejuvenate their portfolio using this approach."

# Six heritage sites receive a combined

The Heritage Lottery Fund (HLF) has announced grants of £47m for six tourist attractions across the UK.

Flax Mill Maltings in Shorpshire has received the largest, with a grant of £12.8m.Winchester Cathedral has been given £10.5m, Windermere Steamboat Museum in Cumbria £9.4m, while Knole – a medieval palace in Kent that includes the former hunting lodge of Henry VIII – will be refurbished.

The investment is a boost to tourism, as research conducted by the Fund reveals the heritage sector generates £26.4bn annually for the UK economy.

# DCMS committee launches inquiry

The Culture, Media and Sport Select Committee has announced it will undertake an inquiry into women and sport in the UK to investigate remaining barriers to women's participation and how these can be overcome.

The inquiry comes on the first anniversary of the London 2012 Games and in a statement, the committee said: "It was hoped the successes of Team GB's female athletes in the Olympics would result in greater prominence for women's sporting achievements and encourage more to participate in sport.

"However, it appears that women and girl's sport still faces a number of disadvantages compared with sport for men."

## **Exercise could prevent Alzheimer's**

Exercise could be the best way of preventing the development of Alzheimer's disease in elderly people, according to researchers at the University of Maryland School of Public Health who have published a report in the Journal of Alzheimer's Disease.

The findings suggest exercise stimulates parts of the brain associated with memory and helps reduce the progression of mild cognitive impairment (MCI).

The study focused on adults

between the ages of 60 and 88 who were physically inactive and placed them on a 12-week exercise programme.

Of the two groups studied - including those with and without MCI - both showed an increased ability in memory recall and an increase of over 10 per cent in cardiovascular fitness.

The scientists also identified that after exercise, both groups of older people used less brain power to recall the correct answers, showing improvement in cognitive efficiency.

The researcher group is planning a largerscale study to compare healthy individuals with those more prone to the development of Alzheimer's. Details: http://lei.sr?a=3O5c9

#### Majority say Olympic budget was money well spent

More than two thirds of the UK public feel that the £8.77bn cost of hosting the London 2012 Olympics was worth it, according to a survey of 3,218 adults conducted by research consultancy firm ComRes for the BBC.

The findings also suggest that 74 per cent

would support the event coming back to Britain, while participation figures suggest 11 per cent of people are exercising more than they did a year ago. This figure then increases to 24 per cent for those aged between 18 and 24 years old. *Details: http://lei.sr?a=D2y6L* 

#### Sportivate enables 250,000 young adults

Sportivate, one of Sport England's flagship London 2012 legacy programmes, has reached more than 250,000 young adults in the country.

Figures published by Sport England show that a total of 256,000 teenagers and young adults have so far benefitted from free or discounted courses in 70 different sports.

Each course runs for six to eight weeks and an encouraging number of partipiants taking part in the scheme -215,000 out of the 256,000 - completed their courses

without missing more than one session.

Backed by National Lottery funding, Sportivate will run until 2017 and has been designed to help 14- to 25-year-olds to get involved in sports by offering discounted and

free sessions in sports ranging from judo and tennis to wakeboarding.

# **Sports club memberships rising**

Sports clubs in the UK have seen membership levels and income increase by an average of 20 per cent in the past two years.

Results from the Sport and Recreation Alliance's (SRA) biennial Sports Club Survey, show that the average sports club's income has risen by 19.9 per cent to £42,845 - compared to £35,736 in 2010.

The increase is closely mirrored by a rise in membership numbers. Over the period from 2011 to 2013, adult participating membership levels have risen by a total of 20.6 per cent.

Perhaps surprisingly, many clubs do not attribute the increases to the London 2012 Olympic Games, with only 13 per cent of clubs saying their membership increased as a direct result of the Games.

More than a third (38 per cent) of clubs who experienced increasing numbers of adult participants between 2012 and 2013, said that there wasn't a noticeable increase after the Games - suggesting that in many cases membership levels were already on the increase.

#### SkillsActive: Olympic Legacy must continue

SkillsActive has welcomed positive results shown in a recent government report on sport and regeneration but also calls for more to be done to continue the Olympic legacy.

A sports participation report from Sport England says that 15.3m adults now play sport at least once a week; 1.4m more than in 2005/6, when London won the Olympic bid.

Ian Taylor, SkillsActive CEO and Olympic gold medallist, said: "We're delighted the report finds that London 2012 not only

boosted the economy, but also has continued to inspire more people to participate in sports."

The Sport England report also found that 52.3 per cent of adults still play no sport at all, and a recent large-scale UK survey showed 25 per cent of boys and 33 per cent of girls aged

To create the model, data was analysed from children between ages 5-18 and compared their

#### New exercise advice needed for children


New exercise advice is needed to protect children from developing heart problems in adulthood, according to research conducted as part of a European Commissionsponsored project.

Published in the *BMC Medicine journal*, the research, which studied 3,000 children, found those under 10 should get between 60 and 85 minutes' exercise each day.

The research observed links between exercise in young children and the risk of developing cardiovascular disease when they reach adulthood.

Of those studied, 15 per cent had high blood pressure and cholesterol levels, which suggested they could be at risk.

The study also found that younger boys may





#### Radical new museum policy planned for Maidstone

#### **Work to begin on Chester Zoo**

Construction work will begin in August on Chester Zoo's £30m Islands project.

The contract to build the development was awarded to engineering company Laing O'Rourke following a nationwide tender process.

Set to open in 2015, Islands will be located in a previously unoccupied area of the zoo's estate and will feature flora and fauna from the exotic islands of the Philippines, Papua New Guinea, Bali, Sumatra, Sumba and Sulawesi.

There will also be a new Indonesian jungle house one of the largest indoor zoo exhibits in the UK - which

will act as the new home to Sumatran orangutans, Sulawesi macaques and a new species for the zoo, the sunda gavial crocodile.

Islands will be the first phase of the Zoo's ambitious, £225m Natural Vision scheme that has been in planning for several years.

First announced in January 2009, the original plans for Natural Vision included a £90m biodome - entitled Heart of Africa - as the first phase, but the project was put on hold indefinitely due to government cuts in 2011.

Simon Mann, Chester Zoo's development director, said: "Islands is a complex project that includes the creation of landscaping themed to each island, an exotic boat journey and worldclass animal exhibits which marry the exact needs of our animals with the best experience

#### Bristol's new family attraction opens

#### **Entering a year** of opportunities



**KURT JANSON** Policy director of Tourism Alliance

t's obvious to even the casual observer that the government's position on visitors to the UK is nothing short of schizophrenic.

It has correctly identified that two of the key ways we're going to get the economy growing again is through increasing the UK's exports to growing economies in Asia and South America and by getting companies in these economies to invest in the UK. The spearhead of this initiative is the GREAT campaign, which has seen the Government commit almost £70m to promoting the benefits of trade with the UK. This investment has been supported by the Prime Minister and senior cabinet members undertaking regular trade-related visits to countries such as India and China.

The success of this initiative is evidenced by the double-digit increases in the UK's exports to Russia, China, India and Brazil achieved over the past year (albeit, from a low base).

However this message of "we are open for business and value your investment" is being critically undermined by cackhanded steps by the Home Office to achieve the dual aims of delivering on the Government's target of reducing net immigration to tens of thousands by 2015 and to win back voters lured away by UKIP.

Driving billboards around areas with high ethnic populations stating that overstayers should give "themselves up or they will be arrested" is clumsy and embarrassing at best. At worst it is disturbingly similar to the efforts of various dictatorships to root-out "subversives".

Then there is the initiative to trial the introduction of £3,000 bonds for supposed high-risk visitors from countries such as India. When this was mooted a month ago the clear message both UK and Indian businesses gave to the Government was that this was detrimental to developing tourism, trade and investment between the two countries. As a result, the Prime Minister quickly back-tracking on the idea. But now, in a second u-turn, the trial is going ahead.

#### English parks contribute £6.3bn

England's national parks contribute between £4.1bn and £6.3bn to the economy each year, according to a report published by National Parks England.

According to Valuing England's National Parks, the total economic activity taking place within the boundaries of England's parks is the equivalent to the UK's aerospace industry.

The report shows that there are currently around 22,500 businesses in the national parks, which have a combined

turnover of £10.4bn, employing 140,000 people, The parks receive more than 90 million visitors each year.

John Dyke, chair of National Parks England, said: "This report really shows the great value of national parks to the economy and national park authorities' role in supporting rural

communities and businesses. It also reminds us of the other benefits national parks provide - clean water, stunning landscapes, wildlife habitats, a place to relax or to be active, to name but a few. These are hard to put a figure on but immensely important to us all." Details: http://lei.sr?a=O4w3E

#### Scottish parks revenues up by 25 per cent

Revenue generated by Scotland's national parks has increased by 25 per cent over the past year, according to research conducted by VisitScotland.

A total of £243m was spent within Scotland's national parks in 2012 by domestic visitors. The Cairngorms and Loch Lomond & the Trossachs National Parks combined, attracted more than one million visitors from the UK and Ireland, with 570,000 domestic visits to Cairngorms, while Loch

Lomond had a further 482,000 visitors.

The research also suggests that The Cairngorms – which is more than twice the size of Loch Lomond and includes five of Scotland's six tallest mountains - is more

#### **Apprenticeship funding is under review**

The government has revealed radical new proposals in a shake-up of the way apprenticeships are funded.

The new scheme would see employers funded directly in order to purchase the apprenticeship training they want, as part of proposals to give businesses more control.

The plans, announced by business secretary Vince Cable, will give employers the freedom to choose the training that's most relevant to the needs of their apprentices and businesses and which represents the best value for money.

Three options have been suggested; the first of which is

a direct payment model, which would involve businesses registering apprentices and report ing claims for government funding through a new online system. Funds would then be paid from the government directly to employers.

The second option would see the use of a PAYE payment model. Businesses would register apprentices through a new online system

and then recover government funding for their training through their PAYE return.

The final option would see government funding continuing to be paid to training providers, but they would only be able to draw it down when they receive the employer's financial contribution towards the training. Details: http://lei.sr?a=u9F4s

#### RLSS adds new first aid qualifications


