New Hertfordshire snow centre set for May opening

A new £23m indoor hub for skiing and snowboarding, which has been built on the site of the former Hemel Ski Slope in Hemel Hempstead, Hertfordshire, is to open on 6 May.

The Snow Centre, which has been built by UK-based company Sir Robert McAlpine, incorporates a 160m (525ft) main slope suitable for skiers of all abilities, a 100m (328ft) lesson slope, a Snow and Rock retail outlet, a café and après bar and a snow play area.

It will also be the only indoor snow facility in southern Britain that holds Centre of Excellence status,



The centre will enable visitors to experience real snow conditions

which has been awarded by the British Association of Snowsports Instructors (BASI). while links have also been established with the Ötztal region in Austria to ensure it

offers the latest Alpine coaching techniques.

Work got underway last year following two years of planning by David Surrey, director of the Hemel Ski Centre, in partnership with Sir Robert McAlpine and Dacorum Borough Council, and it is hoped that the new venue will attract 300,000 visitors in its first year.

Steven Jordan, technical director at The Snow Centre. said: "Everybody will be able to enjoy the centre, from beginners to experts, children to adults; there is something for everyone."

Ten snow cannons will ensure real snow is produced on a regular basis to replicate Alpine conditions, which will be maintained at temperatures just below freezing.

The new centre also features a 72,000sq ft (6,689sq m) living roof planted with sedum.

Leeds City Council secures funding for Holt Park

Department of Health confirms PFI credits towards new £32m leisure centre

Leeds City Council (LCC) has secured funding for the construction of a new leisure and wellbeing centre in Holt Park, near Cookridge.

The Department of Health has confirmed the allocation, in principle, of £32m of Private Finance Initiative (PFI) credits for the new centre, which will combine services provided by LCC's adult social care, youth and sports services, NHS Leeds, and the local community.



The new leisure centre will include a 25m swimming pool

The Holt Park facility, to be called New Leaf Wellbeing Centre, will include a 25m swimming pool, an easily

accessible learner pool with beach, a sports hall and a Bodyline gym. It will also have meeting, conference and multi-purpose rooms that will host health education workshops and exercise classes.

The wellbeing aspects include a hydrotherapy pool, sensory rooms and a rebound room, which is a soft-sided relaxation space with music.

The centre is intended to replace the existing Holt Park Leisure Centre, as well as contribute to the regeneration of Holt Park District Centre.

Marwell opens African Valley

Marwell Zoological Park in Hampshire has opened its new African Valley zone. The opening of the new zone follows several years of planning and has taken a year to construct.

The 20-acre (8.1-hectare) African Valley will see more than 35 Ellipsen waterbucks, Grevy's zebras and ostriches roam together in a new habitat.

The opening coincides with Marwell renaming itself as Marwell Wildlife for the 2009 season

TALKING POINT

Testing Budget offers little relief

At a time when the British economy faces its toughest challenge since the Second World War, there was little respite for the leisure industry as chancellor Alistair Darling increased alcohol duties and ignored calls for investment in tourism in the 2009 Budget. Pete Hayman investigates how industry figures have greeted the news.

COLIN DAWSON chief executive, BALPPA

The Budget is a missed opportunity to promote British tourism and to create much needed boost in employment. Amid all the depressing content of his Budget, the chancellor could have included a measure that would have provided a genuine green shoot by stimulating an industry that is capable of playing a major role in moving our economy in the right direction.

In BALPPA's Budget submission we argued for a targeted reduction in VAT for visitor attractions and accommodation. A reduction to 5 per cent would have boosted Treasury revenues and contributed to GDP growth.

I am mystified why the chancellor did not seize the opportunity to promote British tourism at a time when many people are for the first time in decades seriously thinking about holidaying in the UK rather than going abroad.

BOB COTTON chief executive, **British Hospitality Association**

In his speech, the chancellor said that his Budget would "build on the strengths of the British economy and its people, speed the recovery, providing jobs and spreading prosperity".

It is curious, therefore, that despite its size and importance, tourism didn't get a mention in the speech, while other industries - creative, oil, IT, energy - did. It was an opportunity missed.

Gordon Brown insists that Britain must invest its way out of the economy – yet the Budget has done little to encourage this in tourism.

In 2007, the government abolished the Hotel Buildings Allowance and reduced other capital allowance yet investment in tourism facilities is essentially long-term. Frustratingly, the government is now investing heavily in green and hi-tech industries to pull the economy out of the recession, which take many years to produce a return; tourism can produce a near-instant return.

If the government wants to encourage more new investment, it needs to restore the Hotel Buildings Allowance and the long-term cuts in capital allowances, stop the imposition of additional costs on businesses and stanch the endless stream of new regulations.

The Budget signs a death warrant for thousands of Britain's pubs and for tens of thousands of jobs. Pubs play a vital role in the economy, yet six are closing every day and more than 2,000 have gone in the last 12 months alone.

In imposing additional beer taxes, the government has wilfully ignored the public, landlords, consumer groups, industry representatives and MPs from all parties who have been calling for action to save the British pub.

At a time when the rest of the economy is getting a supporting hand, the pub industry is being singled out for punitive action. Last year, the chancellor raised beer tax by an eye-watering 18 per cent. The latest increase is a further body blow. The result will be more pubs closing, more jobs being lost and more people consuming alcohol outside supervised, licensed premises.

Our campaign with the Campaign for Real Ale (CAMRA) to save pubs as a vital part of British life now becomes a matter of the highest priority. It has widespread public support, cross-party political support plus the support of trade unions such as Unite. The only person who doesn't seem to be listening is the chancellor.

UK parks to receive £14m funding boost

Eight restoration schemes across Britain to benefit from a share of Lottery cash

Eight parks across Britain are to be restored after receiving a share of £14m from the Heritage Lottery Fund (HLF) and the Big Lottery Fund's (BIG) Parks for People initiative.

The funding will also go towards increasing the number of volunteering and training opportunities for more than 1,000 as part of the schemes, which include planting, habitat creation and woodland and event management.

Lichfield's Beacon Park, Minster Pool and the Garden of Remembrance in Staffordshire will receive the largest funding share, with a £3.9m grant set to be spent on transforming the open spaces through the restoration of the park's landscape and historic features.

A scheme to restore Coventry's War Memorial Park in Warwickshire, which commemorates soldiers who died in World War I, has been awarded £2.8m, while the largest park in Sunderland – Barnes Park - will receive £2.4m towards a £3.6m regeneration project.

Elsewhere, MacRostv Park in Perthshire: Stevenage's Town Centre Gardens, Hertfordshire; and Gyllyngdune Gardens in Falmouth, Cornwall will also receive funding, as will Stafford Orchard, Leicestershire; and Burngreen Park in Kilsyth, North Lanarkshire.

In partnership with fellow trust Greenwich Leisure (GLL), Freedom Leisure will also take over the management of two MSDC entertainment venues, Clair Hall in Haywards Heath and Martlets Hall in Burgess Hill. This is not the first time Freedom Leisure and GLL have worked together, previously winning a joint bid to manage K2 Leisure Centre in Crawley.

Clayton gym revamped

▶ Phase one of the £500,000 redevelopment of Clayton Green Sports Centre in Chorley has reached completion, with the opening of its new fitness suite to local residents. Members can now use 40 pieces of Technogym equipment and will soon benefit from a new reception area with a lift, refurbished changing facilities and improved toilets and showers. The crèche and nursery area will also be completely refurbished and a new multipurpose room added to the first floor.

Fusion to manage Oxford facilities

▶ Fusion Lifestyle has announced that it has taken over the running of leisure facilities in Oxford from 30 March after securing a 10-year management contract with the city council. Working in partnership with Oxford City Council (OCC), Fusion has said it intends to improve facilities at seven sites across the city, as well as to reduce overall costs in a bid to rejuvenate the region's leisure services.

Three separate designs for Forest Hill Pools to undergo public consultation

Three redevelopment proposals for Forest Hill Pools are due to be the subject of a public consultation this April in Lewisham, London.

Lewisham Council's shortlisted leisure centre options come from HLM Architects, Allies + Morrison and Pollard Thomas Edwards architects.

It is the second round of consultations to be held on the development, after the council was forced to rethink designs last year. The adjacent Louise House received a Grade II listing by English Heritage, making the construction of a two-pool leisure centre on the site unaffordable.

A final decision on the redevelopment of Forest Hill Pools will be made by the mayor in the summer. According to the council there are two options: either postpone the

development until 2012 in the hope further funding can be found, which means the earliest it can be completed is late 2015, or proceed now and build the centre on Willow Way, 400m from the current site.

Funding would be provided in part by a housing development bringing the completion date to late 2011.

HLM are proposing the redevelopment of the Forest Hill Pools on its existing site and accompany it with housing, demolishing the victorian frontage. Allies + Morrison have submitted similar designs, but plan to retain the frontage and move the commercial and housing aspect to Willow Way.

Pollard Thomas Edwards intend to host the leisure centre on Willow Way and the housing development on the site of the existing pools.

Nottingham City Council (NCC) is behind plans for the new complex, which will replace existing facilities at Noel Street as part of its £18.5m Leisure Centre Transformation Programme to improve sports provision across the city. The funding, which is made available to local authorities across England. is designed to encourage more people to take up swimming by helping to

provide modern facilities and to enhance accessibility.

It coincides with the launch of the government's free swimming initiative for people aged between 16 and 60 years old, which will run until 31 March 2011 and aims to

The new centre, which has been designed by Archial Architects and is being built by ISG Regions, is expected to be completed by April 2010.

A new 15-year strategy has been launched by Liverpool City Council (LCC) in a bid to improve the health and wellbeing of the city's residents through the reduction of obesity levels and ensuring people live longer.

Liverpool 2024: A Thriving International City sets out a series of plans designed to address a variety of public health issues through physical

activity, while also attempting to make the city one of the greenest and cleanest in Britain. partnership, Liverpool First, is implementing the plans following a 17-month consultation with more than 1.500 residents and more than 50 partner organisations.

Among LCC's pledges as part of the 100-page document, the council will look to reduce the level of obesity in adults and children from 2010 onwards, while also reducing the number of smokers to less than 10 per cent of the population.

Fitness First joins forces with Nintendo

▶ The Fitness First gym chain has joined forces with Nintendo Wii to launch a new product line for the games console. First to be released will be NewU Inside Out. which will combine fitness and exercise content with nutritional advice. A full-body workout is being designed by Fitness First. For this, six Fitness First personal trainers have been filmed demonstrating exercises as the designers opted for real life instruction rather than using 3D graphics.

Hengrove Park opening delayed due to recession

A £21m leisure centre at Hengrove Park in Bristol is set to open several months late, due to the impact of the recession.

Simon Cook, Bristol City Council's cabinet member for sports, however, said the project was not under threat. "The council is working with all its partners and key stakeholders to

ensure the leisure centre remains at the heart of the regeneration of south Bristol," he said.

"The infrastructure works to provide road access and utilities to serve the leisure centre are on track. The government has also confirmed that the current funding for the project in the form of PFI credits is secure."

Profits fall at Arena Leisure

▶ Arena Leisure, the UK racecourse operator, has seen a fall in profits and announced that it will not be paying a final dividend. The company saw its shares fall after reporting a drop in pretax profits from £5.9m in 2007 to £4m this year. However, the company said that revenue had increased by 12 per cent to £64.8m. Mark Elliot, chief executive, said: "Arena has delivered a creditable operational performance, growing total attendance across its portfolio of racecourses during the year."

Clubs closed as Rileys enters administration

▶ Rileys, the UK-wide snooker and pool club operator, has announced the closure of 30 properties and the loss of 200 iobs after it entered administration. Simon Allport and Tom Jack of Ernst and Young were appointed joint administrators of the embattled Milton Keynes-based company, although a deal has been reached with Valiant Sports Limited to ensure the survival of 129 clubs, which will continue to operate under the Rileys name.

Luminar chief expects half of clubs to close

▶ The chief executive of Luminar. the UK's biggest nightclub operator, has predicted tough times ahead for the club industry. Stephen Thomas told The Times that half of the UK's 2,700 nightclubs could close in the next 18 months, although he expects many venues to eventually reopen. He told the newspaper that Luminar was not looking to make any acquisitions either, saying that "of the 2,000-odd clubs in the country not owned by us, we'd be interested in less than eight".

Go-ahead for £16m Scunthorpe venue

New 3,200-capacity entertainment facility expected to open by summer 2011

Plans to replace Scunthorpe's Baths Hall with a new £16m entertainment venue have been given the green light by North Lincolnshire Council (NLC).

The new venue, which will retain its original 1930s frontage, will include a standing area for up to 2,000 people, seating capacity of 1,200, conference facilities, a bar and a café.

Work has already started on a tender process to find a contractor to build the new facility, but the decision now means the council can move forward with the appointment of the venue's operator

NLC will also continue with negotiations to find external funding for the scheme, with meetings scheduled to take place between the council and development agency Yorkshire Forward later this year.

However, planning approval was granted subject to a number of conditions, one of which requires the new venue to generate at least 10 per cent of its energy demands through renewable, on-site measures.

Work is scheduled to get underway in April 2010, with the council already agreeing to contribute £10m from its capital programme, and it is hoped that the new facility will

be open to the public in summer 2011.

NLC leader Mark Kirk said: "The decision means we can now press ahead with our plans to provide an entertainment venue that people deserve.

"We announced that we would maintain our commitment despite budget pressures and we expect around 160,000 people to visit the new venue each year."

Wevmouth FC future secured

▶ The future of Weymouth Football Club has been secured after a rescue package put together by two businessmen was approved by the board of directors at the Blue Square Premier League club. According to the *Dorset Echo*, the deal will see Paul Cocks and Shaun Hennessey appointed to the board, as well as the departure of chief executive Gary Calder and director Mark Golsby.

Football centre for Bradley

▶ Residents of North East Lincolnshire will soon benefit from a £2m investment in community sports facilities, following the approval of a new football facility in Bradley. A joint venture between the council and The Football Association (FA) will transform Bradley Playing Fields into a Community Football Development Centre, as part of the FA's drive to develop a network of sports villages across the country.

Funding boost for Scottish cricket

▶ Sportscotland has awarded Cricket Scotland a £415,320 grant to help develop sport in the region. The funding is part of an investment package for the sport which includes support services from the Scottish Institute of Sport, the high-performance arm of sportscotland. The sportscotland investment is also designed to support Cricket Scotland's drive to nurture the next generation of cricketing talent. According to Cricket Scotland figures, a total of 18,000 children were introduced to the sport by primary school teachers during 2008 - an increase of 10 per cent on 2007 figures.

Proposals for £100m university site include Olympic-sized swimming pool

Highlands and Islands Enterprise (HIE) have submitted plans for a sports centre as part of a proposed £100m university campus in Inverness.

The development, to be located on 200-acres of land at Beechwood, is to be called Inverness Campus and will be part of the Millennium Institute's University of the Highlands and Islands portfolio of colleges.

The scheme is expected to generate in excess of £50m a year for the local economy. Designed by MAKE architects, in consultation with planning agents Turnberry Consulting, the proposed facilities include a gym, outdoor sports pitches, a

swimming pool and a public park. An Olympic-sized swimming pool is also a consideration following a campaign launched by Inverness Swimming Club but, although HIE do not oppose the idea, it's not in a position

to fund such as venture. If another organisation is willing to front the cost of a 50m swimming pool then it will be considered.

Construction of the centre is expected to start in 2010 and completed by 2013.

£1.2m cash boost for Plymouth sports scheme

The refurbishment of the UCP Marjon swimming pool is set to receive a £1.2m cash injection from Plymouth City Council to ensure the dual-use provision of the facility.

The project, at the University College Plymouth St Mark and St John (UCP Marjon), is part of a wider rebuild of sports facilities which will also include enlarging the sports centre by 900sg m to 6,253sg m.



The designs of the new centre

A council spokesperson said: "Without the council's investment it is unlikely that UCP

Marjon would have continued to provide swimming facilities, but this new partnership arrangement means the University College can completely remodernise the facility and provide vital public swimming provision."

The pool will be available for community use for up to 70 hours a week – up to 10 hours a day – and students can use the pool for around 20 hours a week to meet their curriculum requirements.

£1m grant for Manchester sports village

The football Foundation has presented a cheque for £1m towards the development of a £10.3m sports, culture and leisure village in Heywood, north Manchester.

The £1m grant, personally delivered by Football Foundation president Lord Pendry, will go towards the new centre which will incorporate a sports hall; 25-metre, six-lane swimming pool; 100-station fitness suite and dance studio plus community and education rooms. There will also be dedicated youth space and a youth gym. The funding comes on top of an earlier grant from Sport England for £500,000, which was also the largest amount they have ever awarded

House of Sport planned for Flintshire

Deeside Leisure Centre to be replaced by multi-million pound sports facility

Deeside Leisure Centre in Flintshire, North Wales, may be demolished to make way for a new facility dubbed the 'House of Sport'.

Flintshire County Council is holding an executive cabinet meeting on Wednesday 1 April to decide how best to move forward with the proposals for a 12-court sports hall, a six-lane indoor bowls hall and an outdoor five-a-side football pitch. A dance room, a martial arts room and a spa centre may also be developed. The existing ice rink will be retained.

Shaftesbury Leisure closure

▶ The district council's withdrawal of a £110,000 subsidy to Shaftesbury Leisure Centre in North Dorset forced the facility to close its doors at the weekend. The decision was announced two years ago as part of the council's medium term financial plan. Regular users of the fitness centre will have to rely on services offerd by Blandford Leisure Centre, while the astro-turf pitches at Shaftesbury Sports College may be open to the public for future use outside of school hours.

Revamp for Ashton centre

▶ Ashton Leisure Centre in Ashton-In-Makerfield, near Wigan, is set to undergo a £600,000 facelift thanks to its early start in offering free swimming for under 16-year-olds and the over 60s. As the centre was one of the first to offer free swimming, the facility's operator Wigan Leisure and Culture Trust was entitled to a cut of the DCMS' £50m capital swimming fund. Having successfully bid to Sport England for the cash boost, the grant will enable the trust to refurbish the centre's learner and main swimming pool and changing rooms.

Construction work has started on the £5m redevelopment of Sheffield Baths in Mansfield.

The facility will be renamed the Rebecca Adlington Swimming Centre when it reopens, in celebration of the facility where the double olympic medalist learnt to swim. The contractor, G F Tomlinson Building, is in the process of adding two lanes to the existing four-lane swimming pool, a new performance athlete pool training tank, a new changing village, a multi-purpose room and an enlarged larger gym.

There will also be a new two storey block with poolside changing rooms and improved disabled access, changing rooms dedicated to schools and clubs. The existing learner pool and pool hall will also be refurbished.

Sport provision boosts participation

▶ The number of people living within a reasonable distance of a quality sports facility has almost doubled in the last few years, The Audit Commission's latest Comprehensive Performance Assessment found that 41 per cent of people living in urban England are now within a 20-minute walk — and within a 20-minute drive in rural areas — of three different types of sports facilities, including at least one quality assured scheme.

Rezidor Hotels signs Brighton properties

▶ DRezidor Hotels has announced the signing of two hotels in Brighton. The Brussels-based firm signed agreements to operate the Royal York Hotel and Landsdowne Place, both owned by Max Hotels, which will be rebranded as the Radisson Blue Hotel Brighton and Park Inn Brighton respectively at the end of April.

Travelodge scoops for Purple Hotels

▶ Travelodge has bought the last three remaining leases from Purple Hotels for £14m. Purple Hotels was owned by The Real Hotel Company, which went into administration in January this year. Travelodge bought the hotels - the 71-room Purple Hotel Tewkesbury in Gloucestershire, the 84-room Purple Hotel Derby in Derbyshire and the 103-room Purple Hotel Sheffield Meadowhall in South Yorkshire - from the company's administrator BDO Stoy Hayward. All three hotels will be rebranded.

Deloitte opts to buy-out GuestInvest investors

► GuestInvest's administrator Deloitte has reportedly made an offer to buy out individual investors of the London buy-to-let hotel operator so it can push forward with the sale of uncompleted properties. According to *The Times* newspaper, Deloitte recently sold a property in Leinster Square, Notting Hill, to GuestInvest founder Johnny Sandelson. The administrator is also understood to be close to agreeing the sale of Blakes hotel in Kensington. The three properties include the 157-room The Nest in Bayswater; The Jones, a £70m development in Bayswater; and The Brewery, in Chiswell Street.

Clapham to accelerate GBK roll out

Restaurant group looking to benefit from falling property prices across the UK

Clapham House Group plans to take advantage of the property market's depleting value over the next 12 months as it prepares to accelerate the roll out of its restaurants.

The operator of The Real Greek and Tootsies, plans to open 150 new Gourmet Burger Kitchen (GBK) restaurants in the UK, after delivering good sales for the year to 29 March 2009.

"We are witnessing a correction in UK property valuations as landlords have begun to adjust their rental expectations for new properties and leases," said the group's trading statement.

"We expect this realignment to accelerate over the next 12 months and will plan our

London hotels 'unfit' for 2012

London hotels have been deemed "unfit" to host guests during the 2012 Olympics by campaign group London Citizens and trade union Unite.

The report, titled Rooms for Change:
Putting London hotels on track for the Olympics, refers to working conditions at London hotels as "Dickensian"; offering low wages, migrant labour and poor value for money.

The report argues that key issues to making the hotels fit for 2012 include adopting the £7.45 London Living Wage as minimum wage, by investing in training and to improve migrant workers' English skills.

RevPAR to fall at capital's hotels



Empty rooms - the trend facing London hoteliers during 2009

London hoteliers can expect to see a 12.7 per cent fall in RevPAR, to an average of £81.62, by the year-end 2009.

In its latest quarterly Hotel Market Outlook, consultants Deloitte predicts that the decline in RevPAR will come as average occupancy will fall 5.8 per cent to just 75.2 per cent.

Average room rates are also likely to take a hit and to settle

at £108.38, a £9 drop on the previous year.

All market segments are expected to see RevPAR decline more than 10 per cent during 2009, but luxury hotels are set to suffer the most with average room rates falling 18.2 per cent (more than a £35 reduction).

The outlook for 2010 looks similar to 2009, with little sign of the recovery. Average room rates are due to fall a further £9 to £99.03.

We can't afford to wait idly for recovery

Investing in our facilities must remain a priority, even in the face of a recession

he summer season is around the corner. What kind of a season will it be? According to TRI Hospitality, occupancy in London is forecast to drop this year by between 10 and 18 per cent and in the provinces by between eight and 14 per cent. Yet, while these are bleak signs, tourism is a remarkably resilient beast. Recovery will come but it will take time. What should we do in the meantime?

Firstly, and most importantly, we must continue to invest. The hotel industry alone has invested £5bn in each of the last five years and opened 1,000 new hotels. Many new restaurants have opened. The recession, however, means that this investment is already slackening. Yet it is precisely now that the industry needs tax and

fiscal incentives to encourage continued investment in new hotels, restaurants and new attractions.

Secondly, investment in staff training and staff development is key to success. Staff costs represent 30 per cent of turnover in a hotel and over 40 per cent in a restaurant. We need to ensure that the staff we have are fully trained so that they offer the best service possible for our guests.

Incentivising the use of training schemes and short training courses is critically important. There is a plethora of qualifications in the industry that are not understood by employers; they must be simplified so that employers understand what skills people have. Benchmarking schemes, too, are a valuable aid to efficiency and should be supported.

Thirdly, the overwhelming need is for UK tourism to provide even greater value for money. This needs leadership on the part of the government in providing the right economic environment, the right incentives, and the right tourism structure. It also needs leadership on the part of the industry to respond by providing the right facilities, the right welcome and standard of service that guests now demand.

Industry is up for it, but is government? Last week's Budget offered little encouragement other than the doubling – for one year only – of the main capital allowance. If government wants to encourage more new investment, it needs to restore the Hotel Buildings Allowance and the long-term cuts in capital allowances, stop the imposition of additional employment costs on businesses (particularly in business rates, employment and NI) and stanch the endless stream of new regulations.

If successful, according to the Essex Echo, the council will match the investment with money from its public coffers.

Bedford Gallery reopens after revamp

▶ Grade II-listed Bedford Gallery in Bedfordshire, built in 1841 and closed in the 1970s, has been reopened following a £2.5m refurbishment. The project is the first phase of a wider £11.3m regeneration scheme designed to unite the Cecil Higgins Art Gallery and Bedford Museum buildings. When completed, Bedford Gallery will feature more than 200sg m (2,152sg ft) of temporary exhibition space.

Seal of approval for Shetland arts venue

▶ Construction work on the new £12m music, cinema and arts venue located on the Shetland Islands is expected to begin this month. The Mareel centre, on track to open in 2010, will be situated on Lerwick's waterfront and has been designed to drive Scotland's burgeoning cultural and economic development forward. Designed by Gareth Hoskins Architects on behalf of the Shetland Arts Development Agency, the facility will comprise a 330-seat auditorium, a 159-seat digital cinema, performance rehearsal space, a recording studio and a café bar.

Birmingham's REP theatre set for revamp

▶ The Birmingham Repertory Theatre (REP) will be undergoing a £193m overhaul as part of a joint scheme to redevelop the Library of Birmingham. The joint venture, led by Birmingham City Council and The REP, is designed by Dutch architect Mecanoo to create a 31,000sq ft (2,879sq m) "centre for culture and knowledge" in Centenary Square. The library will be integrated with The REP at the ground floor and mezzanine levels. They will also share a foyer, a café, a bar, a restaurant and a new 300-seat studio theatre.

London's Whitechapel Gallery reopens

The £13.5m project merged the venue with an adjacent library to increase its size

The new £13.5m expansion of east London's Whitechapel Gallery is now open.

The gallery, redesigned by Belgian architects Robbrecht & Daem and Witherford Watson Mann, is almost double the size after it merged with the adjacent Passmore Edwards library (built in 1892) increasing the 3,000sq ft (279sq m) space by 78 per cent.

New features include three galleries dedicated to international art collections, new art commissioned by the gallery's trust and an archive collection and a research room to document the last 100 years of the gallery and local area. Other new facilities consist of


New-look Tate Modern project gets the go-ahead

The new £215m Tate Modern extension, designed by Swiss architects Herzog & de Meuron, has been approved by Southwark Council in London.

The project, called Transforming Tate Modern, will feature an 11-storey glass tower in the form of a spiraling stepped pyramid on the south-west corner of the existing gallery.

The building will be 65m (213ft) tall and will add

21,500sa m (230,400sa ft) to the Tate existing 35,000sg m (377,000sq ft) of gallery space.

Original designs – which resembled a stack of bricks were scrapped by the gallery after winning planning approval in 2007. The new designs are created around three oil tanks from the former Bankside Power Station, which will be used as exhibition space.

The new-look Tate Modern will also boast two new public spaces – a southern square modelled as a city piazza and new child-friendly gardens to the west.

New Ipswich theatre gets £75,000 cash injection

Ipswich Borough Council (IBC) has announced it will contribute £75,000 towards a £400,000 scheme that will establish a new theatre on the town's waterfront, scheduled to open in 2010.

The grant will go towards fitting out the 220seat Witchbottle Theatre – a new base for the Red Rose Chain – for theatre and cinema

performances and will feature a café, offices and a film editing suite.

Judy Terry, IBC portfolio holder for arts, culture and leisure, said: "With this grant, we are helping the company build on its reputation for providing exciting theatre and film projects with a broad appeal."

It follows the news that the London Borough of Lewisham has been awarded a £2m grant by the LDA as part of the Thames Gateway Parklands plan, which has received funding from the Department for Communities and Local Government's Parklands Fund.

Five parklands will undergo extensive refurbishment work as part of the scheme, including Three Mills Green in the Lea River Park; Dagenham Washlands: Rainham Riverside:



The schemes will include the redevelopment of the Lea River Park

Erith Marshes; and Waterlink Way and Deptford Loop.

Plans for Waterlink Way and Deptford Loop includes the upgrade of cycle and footpaths from the Thames to Outer London, as well as new wetlands and new backwaters.

New cycle and footpaths also form part of plans for Dagen-

ham Washlands, while Rainham Riverside will see an increased public access to the Thames waterfront and expanded marshland wildlife habitats.

The scheme forms part of the East London Green Grid, which has been developed by a number of stakeholders including the Mayor of London.

Woodland scheme for Northern Ireland

▶ Newtownabbey Borough Council has joined forces with the Woodland Trust to offer local residents the chance to take part in a scheme that aims to see 50,000 new trees planted in the borough during 2009. As part of the initiative, landowners will be given the opportunity to benefit from two planting options depending on the size of land applicants wish to to plant on - the first of which offering 50 free packs of 100 trees to plant on small areas around 0.25 acres (0.1 hectares).

Gateshead riverside restoration complete

▶ Saltmeadows Riverside in Gateshead has reopened to the public following the completion of a £2m restoration scheme after the site was found to be heavily contaminated in 2005. Keelman's Way, a long-distance cycleway that forms part of the national cycle network, has been restored to its original riverside route, while the picnic area has been made fully accessible. The Keelman's Way cycle route has also been completely tarmaced.

New outdoor activities centre opens in Falkirk

▶ The Waterways Trust Scotland

and Falkirk Council have opened a £1m outdoor activity centre designed to get young people in the region more active. The Action Outdoors centre has been built on the bank of the Union Canal and will allow young people to engage in activities such as canoeing, cycling, rock climbing and angling. The project received funding from numerous sources including sportscotland Lottery Fund, the Scottish Government, Falkirk Council, and Big Lottery Active Futures.

Stanwick Lakes unveils new £2.2m visitor centre

A new £2.2m visitor centre has opened at the Stanwick Lakes countryside attraction and nature reserve near Higham Ferrers, Northamptonshire, as part of a two-phase project.

The facility, which marks the completion of the first phase of the construction scheme. includes a central atrium containing an interpretation space and interactive exhibits, a multi-purpose function suite and an indoor play area for young children.

A café with terrace overlooking the lake and a gift shop also form part of the centre, which was designed by architects Laurie Wood, and built by Corby-based company, Jeakins Weir. Saturn Projects acted as project managers.



The facility has been designed to meet its own energy needs, including a combination of solar power and a ground source heat pump, while a wind turbine will be installed later this summer. Rainwater harvesting will also be used to flush the toilets, and a sedum living roof has been created to improve insulation.

East Northamptonshire Council helped to fund the project, along with North Northamptonshire Development Company through the Department for Communities and Local Government, Northamptonshire Enterprise through the East Midlands Development Agency, and River Nene Regional Park.

Developer announced for Basildon scheme

▶ Basildon District Council has appointed Community Solutions for Leisure (CSL) as developer of the £35m Basildon Sporting Village. CSL will now finalise the design - and eventually build the new centre and its 50m Olympic-size sized pool. The council cabinet's decision brings to an end a 15-month procurement process. The Sporting Village is supported by £5m funding from Essex County Council and the Homes and Communities Agency.

Construction starts on 2012 handball arena

▶ Work on the new Handball Arena for the 2012 London Olympics is set to get underway this summer after the Olympic Delivery Authority appointed **Buckingham Group Contracting** to build the venue. The Milton Keynes-based company will work with HOK Sport on the construction of the 7,000-seat facility, which has been designed by Make Architects with PTW and Arup and is set to become a 6,000-seat multi-sports venue after the Games.

Toolkit for cultural regeneration plans

▶ A government-funded partnership has launched a Culture, Sport and Planning Toolkit to guide developers on ways to integrate cultural and sporting facilities into regeneration schemes. The online resource brings together new and existing tools to incorporate planning for culture and sport into developments as well as providing advice on integrating them into an infrastructure.

New leisure complex for Isle of Man

New mixed-use centre to be built on the site of the former Summerland building

A new multi-million pound family leisure complex is set to be created on the Isle of Man after development proposals put forward by the Sefton Group were selected by the island's government.

The island's Department of Tourism and Leisure revealed that the Liverpool-based developer was chosen following a formal expression of interest process for The Wave development, which will be built on the site of the former Summerland complex.

Sefton Group has now been awarded a temporary license on the site for up to four months in order to allow the company to carry out detailed investigations of the site, before a formal long-term lease

will be sought from the Tynwald – the parliament of the Isle of Man.

Initial plans for The Wave include a multiplex cinema, a ten-pin bowling facility and exhibition areas capable of accommodating skating. Casino and bingo facilities are also

earmarked for the complex, as well as restaurants, bars and conference facilities.

It is hoped that all necessary site surveys and approvals for the scheme to replace the Summerland centre, which was damaged by fire in 1973, will be concluded by 30 June.

Council settles Sports Village bill

Shrewsbury Borough Council (SBC) has finally agreed to settle the £8.5m construction bill for the city's Sports Village.

The original £6.9m budget agreed with leisure developer Bluestone — formerly Morgan Ashurst — rose by £1.6m more than determined at the outset of the project.

SBC leader Peter Nutting said: "Following negotiations between the borough council and Morgan Ashurst, agreement was reached for a full and final settlement of the Sports Village account. The sum agreed is £8.5m and this is

within the budget agreed by the full council last year."

The payment will put an end to three years of disputes between the council and the developer regarding the final budget and alleged faulty workmanship.

£100m scheme for Newry

Plans for a £100m mixed-use development in Newry have been submitted to the Northern Ireland Planning Service.

The development, proposed for a 32-acre site, includes a 10-screen cinema complex with five restaurants, a coffee shop and landscaped park.

The plans also comprise 29 affordable homes as well as a business park set to create more than 1,000 jobs. Construction on the project is expected to begin by the end of 2009.

New £2m plan to promote London overseas

In March, CLC agreed to close the centres, as well as withdrawing funding for its arts service and the transfer of the city's marketing to Lincolnshire Tourism.



REPs hopes to attract more degree students to join the register

REPs to set up new test centres

Oversees qualifications to gain industry recognition

The Register of Exercise Professionals (REPs) is working with awarding bodies and training providers to establish test centres across the UK to help assess people's knowledge and skills against industryrecognised standards.

The move is in response to the increasing demand from overseas applicants and individuals from higher education wishing to join the register. According to REPs, a large number of international and higher education applicants with degrees are unable to prove their knowledge competence and skills against the sector's agreed standards.

REPs has invited training providers to opt into the scheme to provide Accreditation of Prior Learning, which allows individuals to discuss their qualifications and will enable them to go straight to assessment without participating in a training course.

Registrar Jean-Ann Marnoch added: "We hope this will allow highly knowledgeable fitness professionals to begin working as REPs members."

Trust to invest in 'people skills'

South Suffolk Leisure Trust (SSL) has introduced a new personal development programme to improve the people skills of its staff.

BEE - The People Programme has been developed by FitPro and SSL is one of the first organisations in the country to use it.

It works on the basis that customer satisfaction and loyalty are directly related to the ability of staff to communicate on a personal basis, engaging with customers and building rapport and relationships.

Tracey Copping, chief executive of South Suffolk Leisure – one of the pilot sites – said: "The staff are really excited and motivated. Most passed their training with flying colours and are now putting their new-found coaching skills in to practice with their colleagues."

Calling for joined up thinking on training

Government needs to stop moving goal posts and ensure a coherent approach to skills

Being employer-led is crucial for us as a Sector Skills Council; it means that employer's needs are at the heart of everything that we do.

Through our current re-licensing process, sector employers have taken the opportunity to shape a number of direct messages to government, which will be delivered through the UK Commission for Employment and Skills, about the skills system and its impact on our sector. The time and commitment of sector employers by engaging with us sends out a strong message in itself; the active leisure and learning sector is engaged with the

skills and education agenda. Through the development of standards, the sector qualifications strategy, new and existing qualifications, employers are shaping the skills of their current and future workforce.

They remain, however, concerned about the unresponsiveness of the government in a number of key areas that impact on our sector. Active leisure and learning needs to be considered a priority sector not only because of its major contribution to the economy, but also its contribution to other key agendas including health, physical activity, social cohesion, personal and social development and education. Qualification reform must lead to a well planned and implemented credit-based system however; if we continue to witness an over-hasty transfer of qualifications to the new framework it will compromise the effectiveness of a well planned and properly implemented credit structure.

We have been lobbying against the Public Service Agreement (PSA) target-driven 'full-fat' qualifications that receive public funding; the nature of our sector doesn't align itself to these larger qualifications. The majority of work places would benefit from 'bite-size' learning which directly reflects employer needs. This learning needs to be part of government targets and attract public funding if our sector is to continue to flourish.

There needs to be a greater return on employer investment into developing the skills system. Our strong engagement over the past five years with employers has been hugely beneficial for the sector. This needs to be further acknowledged at government level as employers will become reluctant to engage in government-led processes through us if they feel that once asked for their opinion, nothing changes as a result. And finally, the government must stop moving the goal posts and ensure a joined up approach to skills across departments.

Nikal secures future of £150m Altair development

Altrincham town centre set for radical overhaul after property firm acquires shares from collapsed developer

Plans are back on track for a £150m scheme designed to transform the centre of Altrincham, Greater Manchester, after property firm Nikal acquired the remaining shares in the joint venture for an undisclosed sum.

The future of the mixed-use development had been thrown into doubt following the collapse of the David McLean Group, the North Wales-based developer which entered administration in late 2008.

Plans for the Altair scheme includes a 3.000-seat ice rink that will be home to the Manchester Phoenix ice hockey team and 15,000sq m (161,460sq ft) of retail and a 100-bedroom hotel, restaurants and two new public squares.

Designed by architect Ian Simpson, the plans also include 150 luxury apartments, a car park and 8,000sq m (86,111sq ft) of office space, and now depends on Trafford Council securing the necessary land acquisitions for the scheme to move forward.

Companies handed chance to defer business rates

Businesses will be given the opportunity to spread the payment of this year's rise in business rates over a period of three years under new plans announced by the government.

Under existing legislation, business rates are adjusted every April in order to fall in line with the Retail Prices Index for the previous September. However, the inflation rose to 5

per cent last September, meaning businesses would face a serious impact of their cash flow this year.

Chancellor Alastair Darling is allowing companies to pay just 2 per cent more this year, leaving them two years to pay the remaining 3 per cent over the following two years.

"The government recognises that businesses need help now to ease their cash flow at a time when money is very tight," said Darling. "This measure will help businesses to smooth their rates payments over the next three years."

Water sports centre handover

The handover of the site took place on 1 April and the council is now set to receive more than £10m for the development of new facilities.
